<u>Noscussion and Possible Action – Issue Paper – Contract for Milling Services on CTH D (Creedy Road – Eau Claire Road).</u> Supervisor Rashkin moved the issue paper, second by Supervisor Mulligan. Mr. Jorgenson explained and answered questions from the committee concerning the issue paper. WISDOT and DPW studies have concluded this area to be a safety concern. Contracting this component of the project and having the other portions of the project done by DPW crews will allow the work to be accomplished quicker and more cost effectively. ADOPTED.

<u>Discussion – WCHA and WCHA-LDG Scholarship Opportunities.</u> Mr. Jorgenson explained the scholarship opportunities and answered questions from the committee. Supervisors Mawhinney and Rashkin suggested distribution to local schools and universities.
