<u>Approval of Minutes of February 11, 2016.</u> Supervisors Fox and Richard moved the minutes. MOTION CARRIED.

Approve Purchase of Equipment:

One 28" Contractor Grade Stump Grinder. Supervisors Fox and Driscoll moved to purchase stump grinder. Mike Turk recommends purchase from Bobcat for \$9,250. MOTION CARRIED.

One Single Axle Dump Truck Chassis. Supervisors Richard and Fox moved to purchase single axle dump truck chassis. Duane explained we are recommending the purchase of one single axle dump Mack truck chassis from Kriete Madison Truck even though it is not low bid. Due to the fact that the vast majority of our trucks are Mack, and we have inventory on hand for those vehicles and our mechanics are trained to work on those vehicles, we are recommending the purchase of one Mack truck from Kriete Madison Truck for \$112,227. Approve Resolution Motor Pool Budget Authorization for Two Ford Fusions. Supervisors Richard and Fox moved the resolution, authorizing the purchase of two Ford Fusions for \$35,184 from Ewald Automotive. Mike Turk stated these vehicles are being ordered for the Human Services Department. MOTION CARRIED.

Approve Resolution Motor Pool Budget Authorization for Three 2016 Dodge Grand Caravan 4-Door Wagons. Supervisors Arnold and Richard moved the resolution, authorizing the purchase of three Grand Caravans for \$63,252 from Ewald Automotive. Mike Turk stated these vehicles are being ordered for the Human Services Department. MOTION CARRIED.

Approve Voucher over \$10,000 – Foley Electric for \$26,192.45. Supervisors Arnold and Richard moved the voucher. This is partial payment for the generator project.
