<u>Set Committee Meetings Days and Times.</u> Discussion took place on changing the current schedule of the Parks and Highway Committee meetings. Discussion took place on combining the Parks and Airport meetings. Supervisor Driscoll motioned to move item (4) Set Committee Meetings Day and Times to the Highway Public Works Meeting Agenda on Thursday, May 10, 2018. Supervisor Richard seconded the motion. MOTION CARRIED.

Minutes of the Rock County Public Works Committee May 8, 2018

<u>Citizen Participation, Communications and Announcements</u>. Chair Bussie Introduced the members of the Parks Advisory Committee to Supervisor Zajac.

Mr. Presny announced the Friends of Rock County Parks had a meeting on May 3, 2018. At the meeting the group drafted bylaws and plan to apply for a 501c3 non-profit organization.

## **PARKS BUSINESS**

<u>Discussion – Current Operational Procedures</u>. Mr. Jorgenson stated the Rock County Parks Manager and Community Coordinator positions are currently vacant. He reported all projects and maintenance will continue with no changes to the current operational procedures. Mr. Elmer will be serving as the interim until the Manager's position is filled.

<u>Discussion – Project List.</u> Mr. Elmer provided the Committee with a project list for the Parks. He stated the list includes projects and maintenance activities planned in the Rock County Parks. Discussion took place on projects on the list. Discussion took place on gravel work at Gibbs Lake and Magnolia Bluff horse lots. Mr. Finney stated equestrians do better on a grass lot than gravel. Mr. Jorgenson stated the parking lot at Lee Park will be paved this Thursday. The project list for Parks is the same concept as the Highway project list. The project list will help organize projects and keep everybody on task.

<u>Discussion – Position Plan (Park Manager & Community Coordinator).</u> Mr. Jorgenson announced the Parks department currently has two vacant positions. The Parks Manager position will be posted and filled first. The Parks Manager will then determine the needs and responsibilities of the Community Coordinator. Discussion took place on the savings to the budget of the wages and where the funds go.

<u>Discussion – Happy Hollow Park Bathroom.</u> Mr. Elmer confirmed the asbestos inspection has been completed. Discussion took place on the asbestos testing. Mr. Elmer stated the bids are due for the new bathroom on May 10. The demolition of the existing bathrooms are scheduled for the end of June.

<u>Next Meeting Date</u>. The next Parks meeting is tentatively scheduled for Tuesday, June 12, 2018 at 8:00 a.m. at the Department of Public Works.
