#### AIRPORT BUSINESS

<u>Discussion and Possible Action on Terminal Restaurant Build-Out Terms.</u> James Otterstein went over list of possible build-out options with the Committee. Discussion. Supervisors Fox and Arnold moved to approve drafting a resolution authorizing up to \$75,000 for a white-box build-out. MOTION CARRIED.

Supervisors Fox and Driscoll moved to authorize James Otterstein and Ron Burdick the ability to negotiate with clients to move the process along. MOTION CARRIED.

#### **HIGHWAY BUSINESS**

Approve Policy on Permitting Pressurized Liquid Pipeline Crossings of County Trunk

Highways. Supervisors Fox and Arnold moved the policy. Discussion. Supervisor Richard had questions on this item and Colin Byrnes was invited to discuss shore-land zoning permits.

Supervisor Richard distributed a policy from Washington County to the Committee. Ben explained we have similar standards in our specifications. Colin Byrnes discussed the County's shore-land zoning and floodplain zoning permits. He also discussed the County's conditional

## Approve Equipment Bids.

- Two Tandem Axle Plow Truck Chassis. Mike Turk recommends the purchase of two tandem axle plow truck chassis from low bidder, Madison Truck Sales for \$225,876 (\$112,938 each). Supervisors Fox and Richard moved the recommendation. MOTION CARRIED.
- Two Quad Axle Plow Truck Chassis. Mike Turk recommends the purchase of two quad axle plow truck chassis from low bidder, Madison Truck Sales for \$244,000 (\$122,000 each). Supervisors Arnold and Bussie moved the recommendation. MOTION CARRIED.

<u>Approve Resolution Approving County/Municipal Agreement – Janesville – Innovation Drive.</u> Supervisors Richard and Arnold moved the resolution. Ben explained this agreement between the City of Janesville and the County is to accommodate construction of a new city street called Innovation Drive during the reconstruction of CTH G. MOTION CARRIED.

Approve Resolution to Enter into Intergovernmental Cooperation Agreement with the City of Beloit Concerning CTH G. Supervisors Fox and Richard moved the resolution. Ben explained this turns over maintenance responsibility to the City of Beloit for CTH G between Huebbe Parkway and Philhower Road. MOTION CARRIED.

<u>Cancel Vouchers #316 - #387 & Approve Bills/Encumbrances/Pre-Approved Encumbrance</u>
<u>Amendments & Transfers.</u> Supervisors Arnold and Driscoll moved the vouchers. MOTION CARRIED.
