Mr. Kuglitsch explained this policy was when the County was self-insured and now that the County has a contract with WMMIC we need to bring our policy in compliance with the contract.

Supervisor Kraft moved approval of the above resolution, second by Supervisor Arnold. ADOPTED.

Authorizing Overlap of Position for Rock Haven

"NOW, THEREFORE, BE IT RESOLVED, by the Rock County Board of Supervisors duly assembled this _____ day of _____, 2011 does hereby authorize temporarily overlapping the Staffing Coordinator position not to exceed two months."

Supervisor Bussie explained this is because a long time employee who runs a complex computer system, is the only person who does this, is retiring and with the overlapping of people it will cross-train someone for this position.

Supervisor Bussie moved approval of the above resolution, second by Supervisor Kraft. ADOPTED.

Amending the 2011 Council on Aging Budget for Congregate Nutrition Program, Volunteer Driver Program, New Freedom Program and Creating Position of Mobility Manager

"NOW, THEREFORE, BE IT RESOLVED by the Rock County Board of Supervisors duly assembled this _____ day of _____, 2011 that the position of Mobility Manager be created in Pay Range 13 effective January 14, 2011 through December 31, 2011 and the 2011 Council on Aging budget be amended as follows:

Ms. Lubben explained the Council on Aging uses Federal and State funds and to qualify we need to show we are in compliance. This position will coordinate all transportation providers in the County who receive these funds.

Supervisor Arnold moved approval of the above resolution, second by Supervisor Peer. ADOPTED.

<u>Update on Dates for Collective Bargaining.</u> Mr. Kuglitsch said agreements had been reached with AMHS, Rock Haven and the Deputy Supervisors. The Attorney's group will meet next Monday and this leaves the Juvenile Detention Center. Mr. O'Connell said the agreements need to be ratified and we will, hopefully, be bringing all but Juvenile Detention Center to the next meeting.

Discuss and Take Possible Action on County Redistricting Plan 2011. Mr. Knutson gave an overview of the census process and how it has been handled in the past in Rock County. We will receive the census information by April 1st and the clock will start; April and May the supervisory districts will be revised; June and July the municipalities will have 60 days to set the wards and then send the information back to the County; sometime in September the District Plan needs to be adopted. Ten years ago an ad hoc committee looked into the size and number of districts and the outcome was to stay at 29 Supervisor Districts. He asked how the Committee wished to address the number of supervisory districts. Mr. Kuglitsch said if they do not take any action it will be assumed to stay at 29 districts. Mr. Knutson said it appears that the population will increase by about 9,000 people. The Committee felt nothing should be done and to let the supervisory districts stay at 29. This will be reported to the County Board when a resolution to create a Redistricting Committee is brought to the Board in February.

<u>Semi Annual Out of State Training and Conferences Reports.</u> The Committee accepted the Semi Annual Out of State Training and Conferences Reports from Human Resources, Corporation Counsel and County Administrator.

<u>Claim.</u> Mr. Kuglitsch said they had received notice of a claim from the Rock-Koshkonong Lake District regarding the Slow-No-Wake Restriction Ordinance that it was unlawful and exceeds our authority. His recommendation was to take no action. The Committee agreed unanimously to take no action on this claim.

Executive Session: Supervisors Peer and Arnold moved to go into Executive Session at 4:46 P.M. per Section 19.85(1)(g) Wis. Stats To Confer with Legal Counsel Regarding Potential Litigation. ADOPTED on a roll call vote with the following: Ayes – Supervisors Arnold, Brill, Bussie, Jensen, Kraft, Peer, Podzilni, Yankee; Absent – Supervisor Collins.

Chair Podzilni announced that the Committee would meet in closed session to Confer with Legal Counsel Regarding Potential Litigation as authorized by Section 19.85(1)(9) of the Wisconsin Statutes.

Supervisor Arnold moved to go out of Executive Session at 5:22 P.M., second by Supervisor Yankee. ADOPTED.

<u>Adjournment</u>. Supervisor Arnold moved adjournment at 5:22 P.M., second by Supervisor Jensen. ADOPTED.
