Rock County Support of the National Moment of Remembrance of the 10th Anniversary of September 11th, 2011

"NOW, THEREFORE, BE IT RESOLVED that the Rock County Board of Supervisors:

- (1) recognizes September 11, 2011 as a day of solemn commemoration of the events of September 11, 2001, and a day to come together as a Nation: and,
- (2) offers its deepest and most sincere condolences to the families, friends, and loved ones of the innocent victims of the September 11, 2001, terrorist attacks; and,

- (3) honors the heroic service, actions, and sacrifices of first responders, law enforcement personnel, State and local officials, volunteers, and countless others who aided the innocent victims of those attacks and, in doing so, bravely risked and often gave their own lives; and,
- (4) recognizes the valiant service, actions, and sacrifices of United States personnel, including members of the United States Armed Forces, the United States intelligence agencies, the United States diplomatic services, homeland security and law enforcement personnel, and their families, who have given so much, including their lives and wellbeing, to support the cause of freedom and defend the security of the United States; and,
- (5) reaffirms that the people of the United States will never forget the challenges our County endured on and since September 11, 2001, and will work tirelessly to defeat those who attacked the United States; and,
- **BE IT FURTHER RESOLVED**, that on the 10th anniversary of this tragic day in United States history the Rock County Board of Supervisors call upon all of the people and institutions of the United States to observe a moment of remembrance on September 11, 2011, including (i) media outlets; (ii) houses of worship, (iii) military organizations; (iv) veterans organizations; (v) airlines; (vi) airports; (vii) railroads; (viii) sports teams; (ix) the Federal Government; (x) State and local governments; (xi) police, fire and other public institutions; (xii) educational institutions; (xiii) businesses; and (xiv) other public and private institutions; and
- **BE IT FURTHER RESOLVED** that the Rock County Board of Supervisors encourages the observance of the moment of remembrance to last for 1 minute at 12:00 p.m. Central Daylight Time by, to the maximum extent practicable ceasing all work or other activity, and marking the moment in a appropriate manner, including by ringing bells, blowing whistles, or sounding sirens."

Supervisor Jensen said line 43 should read "Whereas, on the 10th anniversary of that tragic day..." Supervisor Peer moved approval of the above resolution with this change, second by Supervisor Collins. ADOPTED.
