Everyone is waiting for the Federal Stimulus package to be completed to see how states, libraries, and others will benefit. John went to a press conference with Representative Hixon and Senator Robson. Both are very supportive of the libraries.

Ruth Ann and Kathi Kemp from Eager Free Public Library attended the training session for the Digitization project at the University of Wisconsin Memorial Library. About half of the material was delivered to the digitization crew for processing and Ruth Ann is working on the metadata for the photographs that are due at the Memorial Library on February 23.

The resolution for acceptance of the LSTA Grant for Digitzation was moved approved by Walter Shannon and seconded by Jane Thompson. Motion carried unanimously.

2008 ALS Annual report was moved approved by Jose Carrillo and seconded by Karla Nitz. Motion carried unanimously.
