MINUTES OF BOARD OF HEALTH MEETING

January 06, 2021

Call to Order: Meeting was called to order by Chair Peer at 6:00 p.m.

Board of Health Members Present: Chair Peer, Supervisor Rynes, Dr. Meyers, Dr. Winter, Mr. Gresens, Ms. Kolste, Supervisor Williams and Dr.Somaraju.

Adopt Agenda

Ms. Kolste made a motion to adopt the agenda. Supervisor Rynes seconded the motion. MOTION APPROVED.

Approval of Minutes – 12/2/2020

Dr. Meyers made a motion to approve the minutes of the 12/2/2020 Board of Health meetings. Dr. Winter seconded the motion. MOTION APPROVED.

Roll Call

Chair Peer asked for the roll call. At roll call Chair Peer, Supervisor Rynes, Dr. Winter, Mr. Gresens, Ms. Kolste, Dr. Meyers and Supervisor Williams were present. Dr. Somaraju joined after roll call. Supervisor Wilde was not present. 7 PRESENT. 2 ABSENT.

Citizen Participation

Ms. DeWitt read the Recommendation of the Rock County Vaccine Advisory Committee.

Dr. MacNeal from Mercyhealth spoke about this recommendation in regards to their concerns about it, along with the importance of Public Health vaccinating eligible community members.

New Business

Administrative Division

Transfer of Funds Over \$5,000

Review of Payments

The Board reviewed the Health Department's December payments in the amount of \$3,825.74.

Health Department Report

In the News

Ms. Bailey reported on the struggle it will be to find the capacity to have the Rock County Public Health Department to provide community-wide vaccines.

Mr. Wietersen reported on the overwhelming response to vaccinating so many people. He broke the numbers down to include hospitals, clinics, EMS, pharmacists, schools, universities, etc. He suggested the new vaccine coordinator could reach out to all of those partners to see how we could collaborate in order to successfully complete mass vaccinations in a timely manner.

Ms. Kolste questioned whether or not the County has authority to vaccinate in masses.

Mr. Smith and Ms. Chouinard responded accordingly.

Ms. Soderberg touched base on the new variant of COVID-19 that has emerged in England. She commented on facts on how much more contagious it is, which can lead to higher numbers of cases and more hospitalizations.

Dr. Somaraju reported on additional factors regarding the new strains of COVID-19 and also the infusions COVID-19 patients are currently receiving.

Mr. Zupan provided the Board members with the current COVID-19 data.

Mr. Smith commented that CVS pharmacy did come in and begin vaccinating residents and staff at Rock Haven.

Dr. Meyers asked about those who have already been infected with COVID-19 and whether or not they would benefit from the vaccine. Ms. Soderberg and Dr. Somaraju responded accordingly that after 90 days of infection, they would be eligible to receive it.

Ms. Soderberg commented on the testing site at Blackhawk Tech. The Rock County Public Health Department has currently taken this over as the National Guard has exited this site.

Ms. Bailey reported on different types of new testing kits available to various facilities.

Mr. Wesson commented on enforcements regarding complaints against local businesses.

Ms. Chouinard commented on the number one question that has been coming in to the Rock County Public Health Department, which is when and where people can receive the vaccine.

Ms. Turner followed up with additional points regarding communications on when people will be receiving the vaccine. Beyond Phase 1A, the Rock County Public Health Department has not received a lot of information as to who will be included in future phases.

Budget

Ms. Bailey reported that the Rock County Public Health Department is still waiting on federal and state allocations.

Personnel

Ms. Cordova introduced Chelsea Phillips as the newest Public Health Nurse. She also shared updates on the Health Educator recruitment process. Several applicants are being invited for the 2nd round of interviews. She also reported that the Rock County Health Department will be adding 4 additional contact tracing positions. She also reported on the addition of students from various schools and AmeriCorps VISTA (Volunteers in Service to America) positions.

School/Superintendent Updates

Mr. Wietersen reported that final decisions regarding whether or not schools hold virtual or in-person learning is ultimately up to school administrators. Regarding athletics, as questioned by Dr. Winter, it is not the recommendation of the Rock County Public Health Department to move forward with athletics, but some schools have opted to not follow this recommendation.
