Rock County Department of Public Works Division of Highways – Issue Paper

ISSUE - Reallocation of County Highway Construction Funds

<u>DISCUSSION</u> - The approved 2015 County Highway Construction Budget includes \$125,000 for design services for the CTH MM reconstruction project. On July 9, 2015, the Public Works Committee approved Baxter & Woodman, Inc. to begin negotiations for providing design services. Negotiations have resulted in a proposed fee of \$151,582.50.

The proposed fee includes providing initial topographic survey, archeological investigation, geotechnical investigation, culvert inspections, a public involvement meeting, design plans, and a digital terrain model for machine controlled grading.

The proposed fee does not include right-of-way acquisition. Right-of-way acquisition needs will be determined during the design process. Right-of-way acquisition is not expected, however if right-of-way acquisition is needed, fees for those additional services will need to be negotiated.

The proposed fee is \$26,582.50 over the authorized 2015 budget amount.

On June 23, 2015, reallocation of funds from the CTH F (N. Parker Drive to USH 51) rehabilitation project budgeted in 2015, provided \$75,000 for design services for the reconstruction of this same segment of CTH F. On July 9, 2015, the Public Works Committee approved R.H. Batterman & Co., Inc. to begin negotiations for providing design services. Negotiation have resulted in a proposed fee of \$127,505.

The proposed fee includes providing initial topographic survey, archeological and historical coordination, geotechnical investigation, a public involvement meeting, design plans, and a digital terrain model for machine controlled grading.

The proposed fee does not include any of the right-of-way acquisition process. Right-of-way acquisition is not anticipated for this project.

The proposed fee is \$52,505 over the authorized 2015 budget reallocation amount.

The County Highway Construction Account has funds available from 2014 carryover funds that could be reallocated to cover these additional costs for engineering design services for CTH F and CTH MM.

<u>RECOMMENDATION</u> - Authorize reallocation of spending authority of \$79,087.50 (\$26,582.50 + \$52,505.among projects as outlined above.
