Facilities Management Update.

<u>Facilities Management Project Updates as of October 25, 2016</u> Mr. Sutherland explained that the parking lot lights at the Job Center will be done next year with the parking lot project, and the funds will be carried over to next year. Mr. Sutherland went over the projects with the Committee and answered questions.

<u>Energy Performance Updates</u> Mr. Sutherland went over the report, the findings, and future steps to increase savings with the Committee and answered questions. Mr. Sutherland explained that the report is just on the heating and cooling and does not include lighting, etc.

Project Update & Change Orders.

<u>UW Rock County Security Mass Notification Project – Change Orders</u> Mr. Sutherland went over the change orders for doors #8, #16, #109 and #139 and explained that one of the doors did need a magnetic lock. Supervisor Yeomans moved approval of change order CB003 for a total cost of \$2,303, second by Supervisor Heidenreich. ADOPTED.

Review of the 2017 Recommend Budget. Mr. Smith explained that we wanted to provide another opportunity for the Committee and staff to review the recommended budget.

The Committee discussed some of the upcoming projects.

<u>Communications</u>, <u>Announcements and Information</u>. Supervisor Yeomans said he had met with some of the judges regarding security at the courthouse.

Supervisor Homan said he came across a husband and wife, from another state, who were passing through Rock County, had car problems, and the issues in trying to get help for them. He said he appreciated all the people who tried to help them.

Discussion on various agencies in Rock County and some of the services they provide.
