Public Works Committee – Parks Minutes Wednesday, November 13, 2019 – 8:00 a.m. Conference Room N-2 – Fifth Floor Rock County Courthouse-East

<u>Call to Order</u>. Vice Chair Fox called the meeting of the Public Works Committee to order at 8:00 a.m.

Approval of Agenda. Supervisors Richard and Zajac moved today's agenda. Mr. Jorgenson reported an amendment to the agenda: 9e. Should state: Discussion and Possible Action – Issue Paper – Controlled Access Change of Use, CTH G. Rock County Humane society is the incorrect name and should be Humane Society of Southern Wisconsin. MOTION CARRIED.

<u>Approval of Minutes of October 8, 2019</u>. Supervisors Richard and Zajac moved the minutes. MOTION CARRIED.

Citizen Participation, Communications, and Announcements. None.

<u>Parks Advisory Board Communications.</u> Mr. Paynter reported upcoming events in January, February and May 2020 at Five Arch Bridge, Ice Age Trail and Beckman Mill.

### **PARKS BUSINESS**

<u>Discussion and Possible Action – Issue Paper – Gibbs Lake House Lease.</u> Supervisors Zajac and Richard moved the Issue Paper. Mr. Traynor reviewed suggested lease amounts. The Committee agreed to a monthly rate amount of \$824 (\$9,888/year). The Committee agreed to review the potential of the Gibbs Lake rental if/when the current tenant chooses to depart. MOTION CARRIED.

<u>Discussion and Possible Action – 2020 Parks Fee Schedule.</u> Supervisors Richard and Zajac moved the 2020 Parks Fee Schedule. Mr. Traynor reported much research had been done to create comparable fees with surrounding, similar cities and counties. Mr. Traynor also reviewed the new \$50 holding fee required for one-to-three year advance reservations for parks. Mr. Zajac requested a review be done on how the price change effects reservations year to year. MOTION CARRIED.

Parks Manager Report. Mr. Traynor provided information on the items listed in his report.

Maintenance Update – inclement weather has caused delays; tree work is ongoing and all piers are removed except Gibbs Lake's pier will remain.

POROS Plan Update - status is ongoing and a review is expected by Friday, November 15, 2019. Great feedback has been received from the Focus Group Meeting held October 30, 2019.

Safety Training — Training Day (i.e., Flagger, CPR, Safety) was held November 5, 2019 for all DPW employees. Chainsaw Training will be held December 3, 2019 with possible park use on this date. Mr. Traynor intends to notify the Friends Groups. The employee group is full capacity but Mr. Traynor will investigate if private, paying individuals can be accommodated as requested by Mr. Paynter.

Beckman Mill – The Friends Group installed a new paddle gate allowing ADA (Americans with Disabilities Act) accessibility.

Carver Roehl – Mr. Traynor stated the swing set in the park is in disrepair. Mr. Traynor has received a quote from Lee Recreation for the purchase of a new swing set to be installed by the Parks crew.

Turtle Creek Parkway – Mr. Traynor reported weather has caused delays in installation of the kayak launch. The Parks Department has the permits but will have to reapply for them in Spring 2020.

WPRA Conference – Mr. Traynor reported himself, Ms. Friend and Mr. Hessenauer attended the Conference November 5-8, 2019. Mr. Traynor expressed gratitude for having the opportunity to attend the conference. Conferences and classes such as these are very educational and appreciated.

Minutes of the Rock County Public Works Committee November 13, 2019

Community Coordinator Position – Mr. Traynor expressed gratitude for the fully funded Community Coordinator position. Ms. Friend has accomplished receiving over \$103,000 for the Department by completing grant reimbursements in under nine months in her new position.

<u>Community Coordinator Report.</u> Committee members reviewed the report with no additional questions/concerns.

### **HIGHWAY BUSINESS**

<u>Discussion and Possible Action – Issue Paper – DPW 2019 Extended Warranties.</u> Supervisors Richard and Zajac moved the Issue Paper. Mr. Jorgenson reported the warranties are well worth the cost as replacement (transmission, engine, clutch, emissions, EGR, cooler, etc.), without warranty, is exorbitant. The warranties are under budget. MOTION CARRIED.

<u>Discussion and Possible Action – Issue Paper – DPW 2019-2B County Quad Axle Body.</u> Supervisors Zajac and Richard moved the Issue Paper. MOTION CARRIED.

<u>Discussion and Possible Action – Issue Paper – DPW 2019-7 Single Axle Body.</u> Supervisors Richard and Zajac moved the Issue Paper. MOTION CARRIED.

<u>Discussion and Possible Action – Issue Paper – DPW 2019-13 Three (3) One Ton Gas Pickups.</u> Supervisors Richard and Zajac moved the Issue Paper. MOTION CARRIED. Mr. Jorgenson reported the chosen brand of pickups is sturdier, lasts longer, is under budget and obtained at state contract prices.

<u>Discussion and Possible Action – Issue Paper – Controlled Access Change of Use, CTH G.</u>
Supervisors Richard and Zajac moved the Issue Paper. Mr. Jorgenson reported the Humane Society of Southern Wisconsin has requested entrance access permission for their commercial building located on CTH G. Mr. Jorgenson has inspected the area and reported traffic is not significant in this area, wide shoulders exist and vision is good. Future review and/or study of the area will be done if necessary or if changes occur. MOTION CARRIED.

<u>Approval of Agenda.</u> Supervisors Fox and Mawhinney moved today's agenda. MOTION CARRIED.

<u>Approval of Minutes from October 22, 2019.</u> Supervisors Zajac and Fox moved the minutes. MOTION CARRIED.

<u>Citizen Participation, Communications, and Announcements.</u> Mr. Jorgenson requested and Committee approved to move Agenda item 5(m) to 5(a).

#### **HIGHWAY BUSINESS**

<u>Discussion & Possible Action – Issue Paper – Benish Driveway Permit.</u> Supervisor Fox and Chair Bussie moved to continue this matter to the December 10, 2019 Parks and Highway Committee meeting. Mr. Jorgenson reviewed <u>DPW</u> driveway policy and the information contained in the attached Issue Paper. Members reviewed the map as Mr. Jorgenson explained the request and denial per policy. Mr. Benish discussed his request and intentions. Mr. Benish is in the process of purchasing the land (25.9 acres in the City of Janesville). Mr. Benish's initial use for the land

is recreation with the intention to build a home in 5-6 years. County Highway D currently has ten access points on the west side of the highway within .65 miles of the proposed driveway access point. An easement already located on the adjacent property to the north is intended for farm equipment use to access the farmland directly behind Mr. Benish's property. This easement goes through the neighbor's yard and is not practical for everyday use. Prior to this meeting, Mr. Benish spoke to Mr. Wheeler of Rock County Planning, and the item is listed on the agenda for the Planning Committee meeting December 12, 2019. If Mr. Benish is denied at this level, he may choose to pursue further by filing an appeal for variance to the ordinance with the Board of Adjustment. However, prior to this process, Mr. Jorgenson will meet with the Rock County Planning Department and surveyor to fully review policy and procedure pertaining to the legal description of the property and easement. MOTION CARRIED.

<u>Resolution – Recognizing Allen Long.</u> Supervisors Mawhinney and Zajac moved the Resolution. MOTION CARRIED.

<u>Resolution – Recognizing Ray Legris.</u> Supervisors Fox and Mawhinney moved the Resolution. MOTION CARRIED.

<u>Discussion & Possible Action – Bridge Aid.</u> Supervisors Zajac and Mawhinney moved the Bridge Aid. Mr. Jorgenson reviewed the information contained in the attachment and stated funds are available under bridge aid. MOTION CARRIED.

<u>Discussion & Possible Action – Issue Paper – Purchase of One (1) Drum Mulcher/Cutting Head.</u> Supervisors Fox and Zajac moved the Issue Paper. Mr. Jorgenson confirmed this is the skid loader's secondary attachment. The equipment cleans, mulches and will aid in projects for the Parks Department as well when needed. MOTION CARRIED.

<u>Discussion & Possible Action – Issue Paper – Purchase of One (1) 3.5 Yard Wheel Loader.</u>
Supervisors Zajac and Mawhinney moved the Issue Paper. This equipment is for the replacement of equipment used for loading salt, construction, maintenance and secondary snow removal on the interstate. Supervisor Zajac questioned if the contract is different from state contract requirements and Mr. Jorgenson stated he would review and contact Supervisor Zajac directly with the results. MOTION CARRIED.

<u>Discussion & Possible Action – Issue Paper – Purchase of One (1) Single Axle Truck Chassis.</u> Supervisors Fox and Mawhinney moved the Issue Paper. Purchase is for a chassis only. The outfitting for the body is expected at a later date. MOTION CARRIED.

<u>Discussion & Possible Action – Issue Paper – Purchase of Four (4) Mowing Tractors.</u> Supervisors Fox and Zajac moved the Issue Paper. Currently, DPW is leasing mowing tractors and experienced challenges in fulfilling the lease agreement of 300 hours of use per tractor.

Supervisor Fox questioned if these tractors replace priors and Mr. Jorgenson confirmed. Mr. Jorgenson also confirmed prior tractors will be salvaged. MOTION CARRIED.

<u>Discussion & Possible Action – Issue Paper – Purchase of One (1) Track Type Skid Loader.</u> Supervisors Fox and Mawhinney moved the Issue Paper. Mr. Jorgenson reported the tracks on this equipment are holding up well. MOTION CARRIED.

<u>Discussion & Possible Action – Issue Paper – Purchase of One (1) Quad Axle Truck Chassis.</u> Supervisors Mawhinney and Fox moved the Issue Paper. MOTION CARRIED.

<u>Discussion & Possible Action – Issue Paper – Purchase of One (1) Portable LED Message Board.</u> Supervisors Fox and Mawhinney moved the Issue Paper. MOTION CARRIED.

<u>Discussion & Possible Action – Issue Paper – Purchase of One (1) Rollback Trailer.</u> Supervisors Mawhinney and Fox moved the Issue Paper. Mr. Jorgenson reported, of those owned, three are currently out of service. MOTION CARRIED.

<u>Discussion & Possible Action – Issue Paper – Purchase of One (1) CP56B Roller.</u> Supervisors Bussie and Fox moved the Issue Paper. MOTION CARRIED.

<u>Update & Discussion – Project Updates.</u> Mr. Elmer reported overall, projects are nearly 100% complete. The state has agreed to move the remainder of the projects to next year. Mr. Elmer reported most county projects are completed. The remainder of work needed for County Highway A will be completed in 2020. Inclement weather caused delays as equipment changeover for snow removal was needed. Supervisor Fox questioned if street sweeper services are available with the installation of new curbs. Mr. Jorgenson will review and update Mr. Fox with information when obtained. Mr. Elmer reported Town projects are nearly done, with paving to be finished in spring 2020.

Chair Bussie suggested meeting with the contracted towns next year for general discussion. Mr. Jorgenson stated he is expecting to meet with the towns in January/February 2020. Supervisor Mawhinney stated the towns may appreciate some County input on various topics.

<u>Update & Discussion – I-90 Updates.</u> Mr. Elmer reported that there are two lanes north and south from Newville to Janesville with no crossover; Highway 26 and 14 allows for traffic on southbound side only through fall/winter 2020; South of Highway 14 to I-43 – two lanes north and south, with no crossover, are expected to be completed shortly. On the I-43 interchange, two lanes are open in each direction with a median. Completion is expected in fall 2020. On the northbound side only, DPW is expecting to be handling additional winter maintenance on new lane configurations next winter 2020.

<u>Update & Discussion – Rolling Hills Update.</u> Mr. Jorgenson reported that he had a follow up meeting with the Rolling Hills residents and has reviewed well data with the Public Health Department. The Health Department confirmed a well should not be drilled in this area to alleviate the flooding issues. Contamination was a concern as well. Mr. Jorgenson reported that he intends to have a meeting with County personnel to further discuss the situation.

Review of Payments. Nothing further discussed.

<u>Next Meeting Date.</u> The next Highway meeting will be combined with the Parks meeting Tuesday, December 10, 2019 at 8:00 a.m. at the Department of Public Works.

<u>Adjournment.</u> Supervisor Fox and Mawhinney moved to adjourn at 8:51 a.m. MOTION CARRIED.

### Rock County Department of Public Works Division of Highways – Issue Paper

**ISSUE** - Controlled access highway driveway permit request

**DISCUSSION** - CTH D is a controlled access highway as defined under Rock County Ordinance Chapter 4, Part 5 - County Trunk Highway Access Control Regulations. The applicants, Mr. Jonathan and Ms. Courtney Benish, want to add a private entrance to a parcel that currently is accessed by an easement through the neighboring property to the north. (See attached map)

In discussion with the property owner, they intend to initially use the parcel for recreation and site cleanup with a plan to build a house at some point in the future, possibly within five years.

The primary purpose for a controlled access ordinance is to protect the asset of the county highway and to promote the safe, efficient flow of traffic. Every driveway entrance or side road interferes with traffic flow. Either crashes or travel delays occur as more conflicts are permitted.

Ordinance 4.521, Spacing and Frequency includes the following regulations:

- (1) One access may be permitted for each parcel of land as defined under 4.545(6), except where an alternate means of access is available and would better serve the public interest.
- (2) Access permits shall not be issued were the horizontal distances between access points will be less than 600 feet, except as provided under 4.521(1).
- (3) A maximum of eight access points per side per mile of highway shall be permitted, except as provided under 4.521(1).

Ordinance 4.513, Right of Access includes the following:

(2) After designation of a controlled-access highway, no owners or occupants of parcels of land created after enactment of the ordinance will have the right or easement of access, by reason of the fact that their property abuts the controlled-access highway.


The parcel currently has access by easement through the neighboring parcel to the north. The nearest access on the same side (west side) of the highway is approximately 175 feet. This location currently has ten access points on the west side of the highway within 0.65 miles.

<u>RECOMMENDATION</u> — Denial. Based on the ordinances, current access by easement and the quantity of access points in this area, this request does not meet multiple conditions of the Access Control Ordinance.

WHEREAS, the County of Rock (hereinafter Lessee), and more specifically the Rock County Highway Department, wishes to make use of certain property owned by Mr. Todd M Suer (hereinafter Lessor) and more particularly described as:

The West ½ of the South ½ of the East ½ of the Southeast ¼ of the Southeast ¼ of Section 14, Town 2 North, Range 10 East, Spring Valley Township, Rock County, Wisconsin. Containing five (5) acres of land, more or less;

and

WHEREAS, Lessor wishes to lease said land to Lessee.

NOW, THEREFORE, the parties hereto do agree as follows:

- 1. Lessor agrees to let and lease to the Lessee the above-described land.
- This Lease shall be for an initial term of one year commencing on <u>January 1, 2020</u>, and ending at midnight of <u>December 31, 2020</u>.
- 3. The Lessee shall pay to the Lessor an annual rental, payable by January 31<sup>st</sup> of each year commencing <u>January 31, 2020</u>. The rental fee for calendar year 2020 shall be in the amount of \$5400.00 Dollars (\$5400.00) per annum. The rental charge for each subsequent year shall be adjusted for increases in the Urban Rate of Inflation (CPI-U) and shall not exceed 5% annually.
- 4. The Lessee covenants and agrees that it shall comply with all laws, ordinances, and governmental regulations applicable to the premises.

- 5. Each party agrees to be responsible for all damages, costs, and expenses resulting from or arising out of the negligent acts or omissions of said party or their agents or employees.
- 6. Lessee shall only use the premises during the term of this lease or any renewal thereof for the use and purpose of the Rock County Highway Department.
- 7. Lessee shall not have a right to assign its interest in this Lease without the prior written consent of the Lessor.
- 8. Lessee agrees that, upon termination of this Lease, it shall quietly and promptly yield and surrender the premises to the Lessor. Any buildings on said premises at the time this Lease Agreement is entered into and any building constructed on said premises during the term of this Lease or any renewal thereof are and shall remain the property of Lessee, and as such, these buildings shall not be assessable for property tax purposes by the Township of Spring Valley. A copy of this signed lease agreement shall be forwarded by certified mail to the Township Clerk and Assessor by the Rock County Department of Public Works, and proof of such mailing shall remain as part of this lease file.
- 9. If default be made in any of the provisions herein, and such default shall continue for thirty (30) days, after written notice of such default has been mailed or personally delivered by the party claiming default to the party claimed to be in default, the party claiming default may elect to terminate the Lease and declare the term ended.

Re: Annual Town Contract - Changes Proposed for 2021

For the <u>2021</u> Annual Local Road Maintenance Contracts (Annual Town Contracts), I am proposing a change to the language regarding item 20 of the agreement. Item 20 states the following:

20. The town understands and agrees that should it at some future date decide not to utilize the services of the Rock County Public Works Department for road maintenance and construction, the decision to accept them back into such program is at the sole discretion of the County. An administrative fee will be charged by the County for accepting any town back into the program as stipulated on Exhibit A.

The change I am proposing would eliminate the administrative fee charged by the County for accepting a town back into the program. The administrative fee is currently \$1,000.

In lieu of that fee being charged, I am proposing that any town that requests acceptance back into the County program agree to an initial three-year contract. After the initial three-year contract, subsequent contracts would be on an annual basis.

This proposal is being brought forward for the following reasons:

- 1. With budget challenges, towns and the county need to efficiently utilize their funds. An administrative fee has provided for initial set up of accounting and office work on the county's end, but does not get any field work done for the town nor does it cover the initial cost by the county for related equipment or personnel for the town section.
- 2. A three-year contract ensures an opportunity for the town and county to develop a good working relationship. The first year develops a good understanding of expectations and processes. The second year allows for adjustments to occur collaboratively. The third year provides a solid representation of what the working relationship will be moving forward.
- 3. A three-year contract also allows the county to hire personnel and acquire equipment needed in confidence. The initial investment by the county for these items being spread out over three years versus one year will provide lower level of risk on the return of the investment.

I am planning to attend the March meeting of the Rock County Town's Association to discuss this proposal, answer questions and take feedback. I also encourage you to reach out to me with any questions, concerns or comments you have. Our office phone number is provided at the top of the page.

**ISSUE:** Purchase of one (1) 72" Zero Turn Parks Mower.
