COVID Response Update

Katrina Harwood shared a slideshow of the representation of the work that the Health Department is involved in for the county-wide COVID-19 response. Things have remained steady over the past month. Regarding testing, the RCPHD has a partnership in place with Summit Clinical Laboratories, which is providing testing at the RCPHD's Beloit office. Hours of operation are Monday – Friday, 8 a.m. – 4 p.m. This new clinic provides easier access for walk-in testing for those who need it. Regarding vaccines, the RCPHD will begin administering COVID-19 vaccines to the 5 – 11 year old age group beginning Wednesday, November 17th. Reoccurring clinics will be held every Wednesday from 3 p.m. – 7 p.m. at the RCPHD's Janesville office. No clinics will be held the week of Thanksgiving or Christmas.

 - Equality
 - The assumption is that everyone benefits from the same supports. This is equal treatment.
 - Equity
 - Everyone gets the supports they need (this is the concept of “affirmative action”), thus producing equity.
 - Justice
 - All 3 can see the game without supports or accommodations because the cause(s) of the inequity was addressed. The systemic barrier has been removed.
