

Minutes - December 21, 2021

<u>Call to Order</u>: Chair Potter called the meeting of the General Services Committee to order at 7:31 A.M., on Tuesday, December 21, 2021, at the Sheriff's Department.

Supervisor Wilson moved approval of the above resolution, second by Supervisor Homan. Brent clarified that this allows systems to be uniform across county buildings. ADOPTED.

Review, Discussion and Possible Action:

Approval of contract for professional services for the installation of DPW repeater equipment: Supervisor Homan moved approval to contract for the installation of Radio Repeater System of Public Works in the amount of \$18,900, second by Supervisor Brien. ADOPTED.

Approval to purchase a camera system for DPW in Shopiere: Supervisor Brien moved approval to purchase a security camera system for the Department of Public Works vehicle storage building in Shopiere in the amount of \$24,965, second by Supervisor Wilson. Brent stated that when it was built, this was discussed, but the bid drawings did not include this. He clarified that this is to approve the purchase of just the equipment. ADOPTED.

Approval to contract with SGTS for professional services for DPW camera system: Supervisor Brien moved approval to contract with SGTS for professional services to install a security camera system at the Department of Public Works Vehicle storage building in Shopiere in the amount of \$24,960, second by Supervisor Wilson. ADOPTED.

<u>Dr. Daniel Hale Williams Rock County Resource Center approval of final change order #15:</u> This change order was not ready, so this item was skipped.

<u>2021 capital projects update</u>: Brent presented on this. He stated there are quite a few projects that

will have funds carried forward to 2022. Brent walked through the list and explained the reasoning behind some of the project funds being carried forward.

Approval to Retain General Communications to Relocate the 911 Communications Center Dispatch Consoles: Supervisor Homan moved approval to contract with General Communications Inc. in the amount of \$7,950 to move the 911 dispatch consoles, second by Supervisor Wilson. ADOPTED.

Approval to Retain Industrial Roofing Services Inc. to Complete an Analysis and Prepare Plans and Specifications for the Courthouse Exterior Building Envelope: Supervisor Homan moved approval to contract with Industrial Rooding Services Inc. for work on the Courthouse in the amount of \$13,000, second by Supervisor Brien. Brent stated that this is a part of the tuckpointing project. This is estimated to be completed at the Courthouse in 2024. ADOPTED.
