Updates.

Rock Haven

<u>Update Report</u> Mr. Terronez said the State inspectors were in last week and cleared Rock Haven to accept Medicare patients again, but noticed and cited them on the way out that the alarm on the doors was not working properly. He said they are going back to the contractor on this.

Mr. Terronez said the fire department told them that the sprinkler in the mezzanine stairway needs to be moved. He said both of these items will come to less than \$4,000.

Mr. Leu said there is also an issue with the shingles curling and Mr. Keating, Rock Haven Maintenance, is working on this issue.

Courthouse Windows Project

<u>Update</u> Mr. Leu said staff has finished the inventory of the windows and there are more that have failed. He said he feels all the windows will fail eventually.

Supervisor Zajac asked if we could move ahead and replace the windows then apply any credit we receive on the old ones. Mr. Leu said we would not be able to recoup anything then.

Mr. Leu said the windows were put in in 2007 at a cost of approximately \$342,000 and the problems started in 2011.

Courthouse Planters

<u>Update</u> Mr. Leu said the planters will be removed in the spring of 2015.

Chair Brill directed that we reschedule the updates on the Courthouse planters until the second meeting in March 2015.
