Project Update & Change Orders.

<u>Update of Job Center Bathroom – Change Orders</u> Mr. Sutherland went over the change orders with the Committee explaining that the bid had come in \$20,000 over budget and with the change order credits we would now be under budget by \$6,430.75.

Supervisor Homan moved approval of the following change orders: VE#1 toilet room egress - delete doors, operators and electrical for a credit of \$4,203.00; VE#2 for toilet room HVAC reconfiguration for a credit of \$14,750.00; VE# 3 for deletion of ceramic tile and replace with epoxy flooring and FRP panels for a credit of \$7,000.00; VE#4 for construction egress — move from window to toilet room for a cost of \$1,450.00; and AYA VE Cost Saving Request to delete west partition wall and north door to offices for a credit of \$1,927.75; for a total cost savings of \$26,430.75, second by Supervisor Heidenreich. ADOPTED.
