CRIMINAL JUSTICE COORDINATING COUNCIL Minutes – January 18, 2018

<u>Call to Order</u>. Chair Horozewski called the meeting of the Criminal Justice Coordinating Council to order at 3:02 P.M. in the Courthouse Conference Center on the second floor of the Rock County Courthouse-East.

Approval of Agenda. Supervisor Kraft moved approval of the amended agenda, second by Mr. Fallon. ADOPTED.

<u>Approval of Minutes of November 16, 2017</u>. Mr. Perry moved approval of the minutes as presented, second by Mr. Enger. ADOPTED.

<u>Election of Chair and Vice-Chair.</u> Chair Horozewski turned the meeting over to Ms. Pohlman McQuillen who asked for nominations for CJCC Chair. Mr. Enger nominated Mr. Horozewski. Mr. Horozewski accepted the nomination. There were no further nominations so nominations were closed. The group unanimously elected Mr. Horozewski Chair of the CJCC.

Mr. Horozewski asked for nominations for CJCC Vice- Chair. Mr. Enger nominated Mr. Mattingly. Mr. Mattingly accepted the nomination. There were no further nominations so nominations were closed. The group unanimously elected Mr. Mattingly Vice-Chair of the CJCC.

<u>Presentation by the Department of Corrections on Revocations.</u> Chair Horozewski announced that Mr. Enger was recently given a promotion to Region 1 Chief and turned the presentation over to him. Mr. Enger introduced Field Supervisor Jim Neitzel and Administrative Law Judge Rachel Pings who were assisting him with the presentation on the Department of Corrections Revocation process.

Mr. Enger and his colleagues went over the revocation process. They said there are many layers of review and the revocation hearing itself is conducted before an independent administrative law judge through the Hearings and Appeals Office. CJCC members asked about the number of waivers they receive and for some general demographic information of people on probation and those being revoked. Mr. Enger said he would try to get that information for a future meeting. Ms. Pings said there was a Corrections Resource Manual on the Division of Hearings and Appeals website with information on the revocation process.

EBDM Update. Ms. Pohlman McQuillen said the Policy Team and workgroups continue to meet. There are a number of trainings scheduled in February for pretrial reform.

Consideration of Future Areas for CJCC Focus/Action.

Chief Moore said there are some individuals that fall through the cracks despite our efforts. He said there are some cases where the DA won't prosecute because the individual has a mental health issue, but Human Services won't detain the person because they don't meet the standard for an emergency detention. He said these folks are still using a lot of law enforcement resources.

Mr. Brigham said he would be interested in learning more about restorative justices, especially for juveniles and how this is working in other jurisdictions.

Commander Knudson said he wanted to discuss reentry services from the jail at a future meeting. He thinks the county needs more reentry resources.

- EBDM Change Targets In-Depth
- Discussion on admission requirements for Drug Court
- Drug Court team report/early 2018

<u>Citizen Participation and Announcements.</u> Ms. Wickersham said there will be presentation at Beloit College in March on criminal justice reform. Members of the CJCC are invited to attend.

Chief Moore said Lonnie Brigham, received the United Auto Workers Local 95 Martin Luther King Jr. Civil Rights Service Award.
