<u>Approval of Minutes.</u> Supervisors Richard and Arnold moved the minutes. MOTION CARRIED.

AIRPORT BUSINESS

Consider/Approve Resolution Six-Year Statement of Project Intentions for the Department of Transportation Bureau of Aeronautics. Supervisors Arnold and Richard moved the resolution. Ron stated this is a six-year plan for planning purposes and requires state and/or federal funding. Discussion on the proposed projects took place. Mr. Arrowood asked if the alignment or length would change on runway18/36 and Ron replied, no.

Supervisor Arnold asked about building demolition and Ron replied there is one building left to be demolished on the property we recently purchased along USH 51.

Supervisor Richard asked about the wash bay and Ron replied we need a building where our large snowplowing equipment and trucks can be pulled through to wash and clean up.

Approve Voucher over \$10,000 (Voucher No. 9092) to State of Wisconsin \$293,000.00. Supervisors Fox and Arnold moved the voucher. Ron stated this covers the terminal building interior renovations and related work. MOTION CARRIED.

<u>Airport Accounts Receivable.</u> Supervisors Arnold and Richard moved the accounts receivable report. Ron distributed the report. Discussion. MOTION CARRIED.

<u>Project Updates: Terminal Expansion Project.</u> Ron stated the contract is a 180-day project and the contractor, Howard Immel, plans to have it completed by October 1. They will begin work on the interior design on June 2.

<u>Terminal Parking Lot.</u> Ron reported the design is almost done. It is almost \$300,000 over budget for landscape and parking areas. Discussion on the City of Janesville requiring 200 parking stalls and storm water containment charges took place.

<u>FAA 139 Inspection.</u> Ron went over the inspection report with the Committee and deficiencies were discussed. One of the items included a new Aircraft Rescue and Firefighting truck. Our truck is nearly 30 years old. A new one could cost upwards of \$600,000. Discussion on sandblasting pavement markings the FAA previously approved and repainting them took place. Ron stated it was recommended to schedule reconstruction of 4/22 in 2015.
