# COUNCIL ON AGING NUTRITION ADVISORY BOARD MINUTES Wednesday, March 17, 2021

**Call to Order:** The meeting of the Council on Aging Nutrition Advisory Board was called to order at 10:06 a.m. by Chuck Wilson, via Zoom conference, in lieu of being in person at the Council on Aging office, 3328 US Highway 51 North, Janesville, Wisconsin.

**Approval of Agenda:** A motion was made by Janice Turner, seconded by Karen Ferguson, to approve the agenda. Motion carried.

**Introduction of Visitors:** Amy Karas, Nutrition & Health Associates

**Approval of February 17, 2021 Nutrition Advisory Board Minutes:** A motion was made by Tom Brien, seconded by Pat Burhans, to approve the February 17, 2021, Nutrition Advisory Board minutes. Motion carried.

**Citizen Participation, Communications and Announcements:** Chuck Wilson noted that Beloit Meals on Wheels is having a St. Patrick's Day fundraiser at Mary's Place in South Beloit today.

#### **Staff Report:**

<u>Staffing</u>: Linda Hardie stated that progress is being made on filling the much needed full-time Nutrition Program Assistant position. There were 15 persons who applied; at last check, there were five interviews scheduled.

<u>Volunteers</u>: There are now six home delivered meal routes in Janesville (as of March 1); but staffing them has been a challenge. Onboarding has been completed for several new drivers. There are currently five potential drivers who have expressed an interest, but it's been very slow.

<u>Vaccines</u>: All Nutrition Program staff and volunteers became eligible for the COVID vaccine as of March 1, 2021. The guidelines state that "Some public-facing essential workers, including food supply chain....." are eligible. Hardie supplied Nutrition Program staff and volunteers with

a letter, which identifies them as a staff or volunteer and will allow them to garner a vaccine. Sue McGinness asked how many staff and volunteers had been vaccinated; but the answer to that question is not known, as there is no vaccination requirement.

<u>Happenings</u>: Yesterday (Tues., March 16) there was a huge response for the St. Patrick's Day meal. About 80 meals were distributed from Milton; a total of 256 meals were ordered from Best Events. Hardie also stated that Nutrition Program staff spend a lot of time on the phone. She received 2020 statistics from the I.T. department: there were 13,831 calls (4,356 outgoing calls and 6,610 incoming); this translated to 665 hours of phone time. In addition to these, the phone line for the Senior Farmers' Market vouchers was also busy: there were 1,606 calls with 70 hours of phone time. Total for all 3 lines: 15,437 calls involving 735 hours of phone time!

### **New Business:**

Senior Farmers' Market Vouchers: Hardie shared that the first inquiry call regarding the vouchers was received last week. It seems likely that COA will be able to secure an intern from UW-Whitewater to assist with the voucher program again this year. Statistics for 2020 were received from Wisconsin DHS about the SFMNP voucher program redemption rates in 2020: In Rock County, there were 485 voucher packets issued; dollar value of issued vouchers: \$12,125; dollar value of redeemed vouchers: \$8,855; redemption rate: 73%. Statewide, the average redemption rate was 73%; highest redemption rate was in Waushara County, at 90%; lowest redemption rate was in Menominee County, at 49%. Some Board members inquired about possible barriers which might have caused these redemption rates; what Waushara County might have done to get such a good redemption rate; one board member stated that for some, transportation to the farmers' markets poses a significant challenge.

<u>Best Events:</u> Rod Oksuita was not present.

<u>Nutrition & Health Associates:</u> Amy Karas stated that she has been doing her quarterly site visits. Both new site managers are doing a great job. At each of her site visits, she provides nutrition education via printed handouts to those participating in the curbside pickup meals. (Pre-COVID, she used to do a nutrition education presentation to the diners.) During the current round of site visits, she has also provided a handout to the site managers on glove use, which she then reviewed with each of them.

<u>Dining Center / Curbside Pick-up Meal Visits:</u> none.

Home Delivered Meal Ride-Alongs: none.

**Adjournment:** Chuck Wilson requested that Paula email by-laws. A motion was made by Jack Kooyman, seconded by Sue McGinness, to adjourn the meeting. Motion carried. Meeting adjourned at 10:40 a.m.
