Complaint Survey – Nursing Home Surveyor's came on September 19, 2012 because of a complaint about care. <u>Licensed Bed Capacity</u> – Effective October 1, 2012 two beds have been delicensed to make the census capacity of 128. This gives us two more private rooms and the number of beds planned for the new nursing home.

Charter Communications Contract – Ms. Gunderson worked with Charter to come to an agreement for the installation and service for the new building. Ms. Gunderson signed a five year agreement with Charter as part of the new building project.
