<u>Census</u> - The current census is 125. All five beds are in rooms that are not air conditioned, and four of the five are in semi-private rooms.

Activity Report - Senior Management completed the 2013 Budget on time. Ms. Gunderson praised Mr. Sudmeier for doing a wonderful job. Ms. Gunderson's pre-budget presentation also went well. Chair Bussie said Ms. Gunderson did a great job answering questions. Ms. Gunderson said there is good news on the horizon for nursing homes in the way of increased reimbursement. Ms. Gunderson hopes to learn more at next week's LeadingAge and WACH meetings.

Ms. Gunderson is already making plans for moving day. She met with Human Services Department staff and it has been mutually agreed that Health Care Center tenants will contract for housekeeping services for the Health Care Center building beginning September 17, 2012. This will allow Rock Haven's Environmental Services Department staff to focus on Rock Haven and assist with preparations for the move.

The annual county employee picnics will be held September 7, one at Rock Haven (10A to 2P) and the other at the Courthouse (11A - 1A).

Staff Education will focus on mandatory inservice make up sessions.

<u>Finance</u> - Mr. Sudmeier distributed the financial report for the second quarter of 2012. Revenue is at 46% and expenses are at 48%. He expects Rock Haven to be on target at the end of the year. Committee members found Mr. Sudmeier's report to be informative and helpful.
