RE: Rock County Drainage Board Appointments

### Gentlemen:

I write you as Presiding Judge for Rock County. Section 88.17 of the Wisconsin Statutes requires the Rock County Circuit Court to appoint members of the Rock County Drainage Board. In 2014, Presiding Judge James Daley appointed Dennis Beggs, George Andrew, Joe Ryan, and Richard Templeton Jr. to the Drainage Board for terms that expired on October 31, 2018. It appears that new appointments to all four of these positions are overdue. Pursuant to Sect. 88.17(2t), Stats., these four members remain on the board as holdovers, since no successors have been recommended or appointed. The only board member not occupying a position by holdover is Stanley Vielhuber, who was appointed in 2016 to a term that will expire on April 5, 2021 by Presiding Judge Richard Werner. This appointment filled a vacancy created by the resignation of Christopher Dickert.

The Circuit Court cannot appoint members to the Drainage Board without receiving and considering recommendations from the Rock County Board Committee on Agriculture and Extension Education, or three landowners owning property in the drainage district (see Sect. 88.17(2h), Stats.). Pursuant to this statute, I hereby request the Rock County Board's Committee on Agriculture and Extension Education to recommend at least three persons to fill each of the four drainage board positions with expired terms.

Finally, Section 88.17(2), Stats., requires that members of a five-person drainage board be appointed for staggered, five-year terms. It appears that over the years any staggered terms have been transposed into holdover terms. The Court intends now to reimpose the strict letter of the statute. This will result in four members being appointed to the staggered terms as follows: One member for a term of one year, one member for a term of three years, one member for a term of four years, and one member for a term of five years. Recognizing that Mr. Vielhuber's term continues for two more years, this will restore the entire board to staggered terms.
