Approve Resolution Authorizing Award of Contract for Carver-Roehl Park ADA <u>Trail Installation</u>. Supervisors Fox and Arnold moved to award contract to Anglin, LLC of Monroe for \$3,325. <u>Approve Resolution Awarding Contract for Office Lighting Project.</u> Supervisors Arnold and Richard moved the resolution awarding the contract for office lighting to Van Brocklin Electric of Janesville for the base bid of \$47,925.00.

Supervisors Richard and Arnold moved to amend the resolution by adding the following, Be It Further Resolved that periodic payments may be made to the contractor upon approval of the Public Works Committee. MOTION CARRIED.

A vote was taken on the original motion, as amended. MOTION CARRIED UNANIMOUSLY.

Approve Resolution to Award Quotes on Salt/Sand Storage Building Materials. Supervisors Arnold and Fox moved the resolution to award the salt/sand storage building materials to TEK Supply of South Windsor, CT in the amounts of \$8,275.77, \$5,136.70 and \$5,136.70 for a total amount of \$18,549.17 and to amend the resolution by adding the following, Be It Further Resolved that periodic payments may be made to the contractor upon approval of the Public Works Committee.

Approve Lease between Rock County and Todd Suer (Orfordville Pit). Supervisors Richard and Arnold moved the lease of the Orfordville Pit for \$4,800 for 2014. Ben spoke with Mr. Suer and tried to convince him to lower his lease rate but was unsuccessful. Supervisor Richard suggests redoing this lease next year to make it friendlier to the County. Discussion. MOTION CARRIED.

<u>Designate a Portion of CTH M a Class A Highway (Johnstown-Milton).</u> Supervisors Richard and Arnold moved to designate CTH M a Class A highway between STH 59 and USH 14 in the towns of Johnstown and Milton. Discussion on Class A highways took place. MOTION CARRIED.

<u>Approve WisDOT Agreement for Construction – Snowplowing Old STH 26.</u>
Supervisors Fox and Arnold moved the agreement for \$4,999 to snowplow old STH 26 in Town of Milton. MOTION CARRIED.

<u>Cancel Vouchers #1384 - #1528 and Approve Bills, Encumbrances/Pre-Approved Encumbrances, Amendments and Transfers.</u> Supervisors Richard and Arnold moved the vouchers. MOTION CARRIED.

<u>COMMISSIONER'S REPORT.</u> Ben reported one of our trucks was damaged in a rollover accident during the recent ice storm. The driver was not injured seriously
