<u>Human Resources</u> Mr. O'Connell said there are no major increases, mainly just the normal salaries and fringe increases.

Supervisor Peer moved the Committee review/no objection of the budget, second by Supervisor Sweeney. ADOPTED.

<u>Claim.</u> Mr. Kuglitsch went over the claim made by Erie Insurance for Sandra and Frank Parker Jr. regarding a vehicle accident between Ms. Parker and a Rock County Sheriff's squad. Ms. Parker turned in front of a passing squad which was operating in emergency mode with emergency lights and siren activated. Mr. Kuglitsch said WMMIC has denied this claim.
