Supervisor Zajac moved approval of the Eclipse Center lease, second by Supervisor Heidenreich. ADOPTED.

<u>Discussion and Possible Action on Requesting Corporation Counsel to Draft Opinions on</u>
<u>Contract Sanction Language.</u> Mr. Kuglitsch handed out copies of what sanction language could be put into bid documents (attached).

Supervisor Brien moved to table this item to the next meeting as this is a request from Supervisor Nash and he is absent, second by Supervisor Heidenreich. TABLED to the next meeting.

#### **Updates.**

<u>Courthouse Windows</u> Mr. Kuglitsch said the current count of defective windows is 692 out of a total of 928 windows, which is nearly a 75% failure rate. He said the company is obligated to supply the glass.

Discussion on the possibility of getting a cash amount for the cost of producing the glass; storing the glass; and going out for bid and having the chosen contractor store the glass.

Mr. Leu said it will probably be less expensive to put all new windows in.

Supervisor Heidenreich said if we could get the cash value for the windows this would be the way to go. He suggested we release the company for the remaining windows if they do a cash settlement for the current 692 failed ones.

Supervisor Brien moved to have a letter sent with the request for a cash reimbursement, second by Supervisor Heidenreich. ADOPTED.

<u>UW Rock County Campus Dorm Update</u> Supervisor Podzilni informed the Committee that he and Supervisor Kraft met with UW Rock County Foundation members and they said they are still interested in building the dorm.

Mr. Kuglitsch said the property still belongs to the County as they have not put the paperwork through to take ownership. He asked the Committee if the County should continue to wait.

Supervisor Podzilni said the Foundation members said they would like to come before the County Board in February.

Supervisor Kraft said the City of Janesville is requesting approximately \$30,000 in fees to transfer the ownership. She added that the Foundation members are looking forward to working with the new Dean.

Supervisor Podzilni said he and Supervisor Kraft are meeting with the new Dean at 2 P.M. today and may have more to report after the meeting.
