Mr. Varga stated that it should be noted that reference checks will be done for Showers Building Restoration as they have not previously done work for the County. Pending favorable reference checks, everything will move forward.

Supervisor Heidenreich moved approval of the above resolution, second by Supervisor Zajac. ADOPTED.

<u>Communications, Announcements and Information.</u> Supervisor Brien requested a status on the Courthouse Tower demolition. Mr. Leu was not in attendance but Mr. Varga said that they are currently dealing with the structural research. Mr. Smith stated that Mr. Leu will be giving an update at the next committee meeting on the courthouse windows, tower and security. The committee asked that it be noted that they want the Courthouse tower project completed this year.

Mr. Terronez reported that Kevin Higgs is no longer with the Samuels Group but he will continue to work on the Rock Haven design error. The mediation session that was previously scheduled for June has now been rescheduled for July 29.

Mr. Smith reported that Mary Puckett, Printing Services Coordinator, will be retiring in August. It has been decided to fill her position with a .4 FTE as a cost savings for General Services. This will be assessed again during budget.

Adjournment. Supervisor Zajac moved adjournment at 8:09 A.M., second by Supervisor Brien. ADOPTED.
