- 6. Land and Water Resource Management Program Approval of Cost Share Agreements: Tom Sweeney reviewed a cost share agreement for Bernard Hookstead to implement Nutrient Management. Supervisor Sweeney motioned to approve the agreement as presented, seconded by Supervisor Yoss. **Motion Carried**.
- 7. Resolution: Finalizing the Sweeney Property Agricultural Conservation Easement Donation. Supervisor Sweeney abstained himself from the conversation by leaving the room.  A. Option Agreement for the Sweeney Property Agricultural Easement Approval.
 Supervisor Sweeney abstained from the conversation by leaving the room. Supervisor Yoss motioned to approve the Option Agreement as presented, seconded by Supervisor Rebout. Motion Carried.

- B. Agricultural Conservation Easement for the Sweeney Property Approval.
 Supervisor Yoss motioned to approve the Easement document as presented, seconded by Supervisor Pleasant. **Motion Carried**. Supervisor Sweeney returned to the meeting.
- 10. Animal Waste Management Ordinance Review and Updates: Tom Sweeny led a conversation regarding the need to update the Rock County Animal Waste Management Ordinance. Sweeney noted that changes to animal husbandry waste management methods necessitate the proposed changes. Other proposed changes will plug holes that were discovered. Sweeney will be sending the blue lined copy to the Corporation Council for review.
- 11. **Department Update.** Tom Sweeney updated the committee on activities within the department since the last LCC meeting. The Construction Site Erosion Control and Storm Water Management Ordinances proposed changes were discussed. The changes being proposed are those required by changes in state law.
- 12. **Adjourn:** Supervisor Pleasant motioned to adjourn the March 5, 2014 Land Conservation Committee meeting at 8:14 pm, seconded by Supervisor Wiedenfeld. **Motion Carried.**
