# **Staff Report:**

- 1. <u>Special Events Planned for the Holidays:</u> Ranee Goodroad stated that Grinnell Hall is planning a Christmas Show on December 11, 2009. The Gathering Place is hosting a Blue Notes Concert on December 16, 2009.
- 2. Report on Wisconsin Association of Nutrition Directors Conference: Ranee Goodroad reported that one topic of the conference focused on emergency meals. She discovered that Rock County has much better compliance with our "blizzard meals" than other counties. Other topics covered were the Healing Power of Humor, cost effectiveness and improving services to seniors with visual impairments.

1. <u>Rock County Senior Fair Meal:</u> Ms. Goodroad reported that 275 meals were ordered from the Hoffman House, but they had enough food to serve 375. People seemed to really enjoy the meal. Many people donated above the suggested rate. The volunteers from RECAP and Rock Valley Community Programs did a great job.

- 2. <u>Faith Lutheran Relocation Update:</u> Ms. Goodroad stated she is still looking for an alternate site for the Faith Lutheran relocation.
- 3. <u>Joint Holiday Meal Project with Beloit Meals on Wheels:</u> Beloit Meals on Wheels is, again, offering to provide holiday meals to older participants of the congregate and home delivered meal programs for the Thanksgiving and Christmas. Around 12 of the meals go to residents of Scoville Hall.

#### **New Business:**

1. <u>Transition Report with Best Events:</u> Chris Gebhardt reported that Best Events has met with site managers and reviewed the current six-week cycle. They requested that site managers rate the meals on a scale from 1-10. Best Events will keep those meals rated 7-10. They have purchased two additional vehicles that are being converted to deliver meals to the congregate sites.
