- 4. <u>Secretary's Report was given after loan approvals:</u> Mr. Somppi reported that staff had a City of Janesville HOME Monitoring Visit three weeks ago. Discussion added that it took all day and that Janesville had been monitored by HUD and that they are required to monitor all grantees of the Consortium. Mr. Somppi added that resulting from recent training and these monitoring visits, the program was in the process of major procedural and format changes, the first being the new two-page form for the "Request for Committee Action" seen with the current projects. It was noted that Small Cities CDBG Grants of \$650,000 for the City of Edgerton and \$650,000 for the County of Rock are to arrive by the middle of November. Funding is also onboard for about 15 new projects in the CDBG-EAP emergency floor repair program.
- 5. <u>Citizen Participation, Communications and Announcements:</u> Mr. Thompson passed out copies of the Isthmus article on the state of the economy in Janesville that was promised long ago at a meeting.
- 6. Review of Loan Request #06068 D-2: After discussion of this additional work for a previous Home Rehab loan in the Town of Beloit, the board supported the \$1,039 0% interest deferred home loan. Com'r. O'Connell made the motion that was seconded by Com'r. Wood. The motion passed.
- 7. Review of Loan Request #06083 D-1: After discussion of this Home Rehab loan in the Town of Beloit, the board supported this \$4,174 0% interest deferred home loan. Com'r. O'Connell made the motion that was seconded by Com'r. Wood. The motion passed.
- 8. Review of Loan Request #06084 D-1: After discussion of this Home Purchase Assistance loan in the Town of Beloit, the board supported this \$4,200 0% interest deferred home loan. Com'r. Wood made the motion that was seconded by Com'r. O'Connell. The motion passed.
