Opposition to the Proposed Changes in the Medicare Home and Community-Based Services (HCBS) Program

"NOW, THEREFORE, BE IT RESOLVED that the Rock County Board of Supervisors duly assembled this _____ day of ______, 2014 does hereby oppose the proposed changes in the Medicare Home and Community-Based Services (HCBS) program and requests the Wisconsin Department of Health Services, our legislators and Governor Scott Walker to:

- 1) Preserve the full range of options for people with disabilities, including the option to attend and access facility-based vocational and day services.
- 2) Recognize that because of incomplete federal guidelines, the Department of Health Services plan is incomplete.
- 3) Request that the State open another 30-day comment period after the Federal guidelines are complete."

Supervisor Peer moved approval of the above resolution, second by Supervisor Mawhinney. ADOPTED.

Supervisor Mawhinney suggested a letter writing campaign as some of the 300 people Rock County has in programs such as KANDU and Riverfront have been there 25 years and this would be traumatic for them.
