Mr. O'Connell said the Youth Service Center Workers are no longer represented by the WPPA. The wage increase agreed upon was 1.5% effective January 1, 2014.

<u>Discussion About Setting the Salary for the Rock County Sheriff and Clerk of Courts for the 2015-2018 Term.</u>

Chair Podzilni informed the Committee Mr. O'Connell will speak and that no action would be taken today, just discussion. Mr. O'Connell noted that the salaries for the Sheriff and Clerk of Court have to be set for the next four-year term by April 15, 2014. Mr. O'Connell distributed materials and included information prepared by Sheriff Spoden and Clerk of Court Mielke. He reviewed the materials and answered questions from the Committee. The Committee requested Mr. O'Connell to bring back a variety of scenarios for the Committee to consider.

Supervisor Brill thanked Sheriff Spoden and the department for the great job with the baby kidnapping case. Sheriff Spoden appreciated the comment and said he has given thanks to his great staff. <u>Adjournment</u>. Supervisor Arnold moved adjournment at 4:55 P.M., second by Supervisor Brill. ADOPTED.
