- 2. Replacement of blacktop in courtyard area. Est. Cost: \$8,000. Project will be bid out on Monday, May 19th. Bids will be available for committee review and approval at the June meeting.
- 3. Drainage tile repair for beef barn. Est. Cost: Not to exceed \$4,000 Jerry Fox & Son have been hired to replace/repair drainage tile for storm water coming off the beef barn. Project completion by June 1st.
- 4. Electrical upgrades: Replacement of circuit breaker boxes and wiring. Est. Cost: \$3,000 To be completed by fair electrician by early July.
- Repair/replacement of Craig Avenue Gate/Replacement of locks on all security gates. Currently obtaining cost estimates.
- 6. Install bypass valve on water line entering grounds from Memorial Avenue. Est. Cost: \$800-\$1,000. Required by city upon last inspection. Line services water on north end of fairgrounds.
