# <u>Awarding Contract for Phase II - Courthouse Parking Structure Maintenance</u>

# Approving Additional Contingency Funding and Amending 2013 Budget for the Rock Haven Facility Replacement Project

### Jail Project

<u>Update Report</u> Mr. Higgs said the legal issues between Silha and the insurance company are still being worked on. Tri North has turned the close out documents over to Carl and John, who will be going over them the next few weeks. Money is still being held until the Silha issue is over.

# **Rock Haven**

<u>Update Report</u> Mr. Higgs said some of the plants are being replaced and there were some issues with weeds in the prairie grass, which Doug Keating is working on. Mr. Higgs said the extension porches/sidewalks and handicapped access control are going out for bid.

# **Change Orders** Mr. Higgs reported the following:

Program Request #33 (COR#208) pertaining to Construction Change Directive #003 to change the swing of two pairs of dual egress doors at N1 and N4 for a cost of \$9,055.00; (COR#215) pertaining to Construction Change Directive #005.1 directing the Contractor to add additional magnetic door hold opens at the owners request, to add emergency lighting in storage room 60, and UL approved astragals at doors 024.1, 025 and at eight (8) Dutch door locations for a cost of \$33,472.00. For a total cost of \$42,527.00.

Supervisor Brill moved approval of Program Request #33 in the amount of \$42,527.00, second by Supervisor Heidenreich. ADOPTED.

Ms. Prostko said their therapy provider will be doing patient work with Medicaid D. She added that they are also able to provide out-patient therapy for County employees. Ms. Prostko said they are working with families for a family council to meet each month to get patients out of the facility for more activities.

<u>Communications, Announcements and Information.</u> Supervisor Brill asked if the as builts have been turned over to the County yet on the Jail. Mr. Higgs said that Carl and John have them and have asked for a couple weeks to go over them. He added that Potter Lawson will be providing CAD drawings, not as builts.

Mr. Higgs said he will be going over documents for Rock Haven with Doug Keating to make sure everything is in order.
