<u>Call to Order</u>. Chair Owens called the meeting of the General Services Committee to order at 8:00 A.M., Tuesday, February 21, 2012 in Conference Room N-1, Courthouse East.

#### Updates.

#### Jail Project

<u>Update Report</u> Mr. Higgs said the conduit and wiring associated with the UPS system is installed and they are waiting on delivery of the UPS equipment; the countertops and electrical closet doors are installed. The security electronics work for Program Request 30 and 31 were approved based on a certain amount and PR #30 has had additional cost added. Mr. Higgs said he has set up a meeting to sit down, look at and resolve these costs.

**Change Orders** Mr. Higgs said there are no Change Orders at this time.

**Update Report** Mr. Higgs reported the following:

Safety/Use of Site: Mr. Higgs said there have been no incidents or injuries reported; he did a safety audit yesterday and found various areas with rebar caps missing, but overall it was very good. The wind has been a factor with slowing the framing down.

Progress/Planned Activities: Mr. Higgs said the N1 truss and plywood installation and the mechanical/electrical/plumbing rough-ins are in progress; the N2 framing is in progress; the N3 foundations walls are 98% complete; the N4 mechanical/electrical/plumbing under-slab work is in progress and the slab on grade should be complete by the end of the week; the pre-cast is in place and grouted in 90% of the Commons; and the basement slab on grade is prepped and ready for concrete in the Commons.

Quality Control: Mr. Higgs said the mechanical/electrical/plumbing coordination meetings are ongoing; and the mechanical rough-ins in the mock up room are ready for inspection today. Mr. Higgs said they are looking into upgrading to a lifetime warranty on the roof and he believes they will be able to get it at no cost.

Mr. Higgs said they are about two weeks behind schedule but feels they will be able to make this time up.

Change Orders Mr. Higgs said there are no Change Orders at this time.

Chair Owens asked how the update for County Board was coming along. Mr. Terronez said they are looking at either March 8<sup>th</sup> or March 22<sup>nd</sup> depending on the size of the agenda.

Mr. Higgs said the intent when the garage was moved was that it would not have electricity. Chair Owens added that he thought the cost would be left to the department who wanted it.

Chair Owens asked about the entrance at the front of the courthouse. Mr. Leu said the order has been issued and they are waiting for the weather to clear. Supervisor Combs asked if they would see something by early spring. Mr. Leu said they are looking at doing it in conjunction with the parking lot so it may be a little later.
