Jail Project

<u>Update Report</u> Mr. Higgs said he is unable to close out the project as the Tri-North Project Manager is not returning phone calls. He is going to have to call the Vice-President of the firm. There is one door that they are not accepting. They are still in the process of resolving the asphalt-drive. The exterior-lighting project is in-process.

Change Orders Mr. Higgs said there are no Change Orders at this time.

Rock Haven

<u>Update Report</u> Mr. Higgs reported the following:

Safety/Use of Site: Mr. Higgs reported an employee of Capitol Steel Erectors fell off an extension ladder last week and broke his leg. The worker underwent surgery Wednesday afternoon and has been released from the hospital. While the incident is still under investigation, there does not appear to be any specific cause. The remainder of the site appears to be in good shape, all workers are complying with safe work practices.

Progress/Planned Activities: Mr. Higgs said the mechanical rough ins continue and the interior finishes (paint, cabinets) are in progress for N1; mechanical rough ins continue and drywall finishes are in progress for N2; mechanical rough ins continue and drywall installation is in progress for N3; mechanical rough ins continue and drywall finishes are in progress for N4; mechanical rough ins continue, finishing up vapor barrier and hat channel with drywall starting, also working on Geothermal vault tie in for the commons area. The concrete work is complete and the foundation for Team Building 1 is complete for the courtyards 1 & 2; concrete work is complete for courtyards 3 & 4.

Informational: Mr. Higgs said they have one hundred sixty people on site.

Administrative: Mr. Higgs said the request for information -379 issued, 25 unresolved or open.

September 12th they will begin at the Health Department and Council on Aging parking lot and then will go to the Sheriff's Office.
