<u>UW-Rock Mass Notification and Security Systems Report – Discussion and Recommendation Relative to the Project's Scope and Engineering Design Services Needed.</u>

Mr. Leu handed out a memo from Dean Wilson outlining the current system, the security recommendations from the consultant's report and what she feels is most critical to the safety of the campus; a fee proposal from Arnold & O'Sheridan for engineering the bid documents and management of the project through construction for the Security Electronics System Upgrade and the Emergency Mass notification System Implementation; and the cost breakdown for Existing System Upgrades and Expansion and New System Implementation (attached).

Dean Wilson said the Mass Notification System is the most important to have for the security of the campus.

Mr. Pronschinske said, for the most part, the project can be broke apart to do the Voice Communication, Distributed Antenna and Emergency Mass Notification, but it is best if it is kept together.

Mr. Knutson asked if it were decided to do part now and the rest in 2 to 5 years would there be any problems. Mr. Pronschinske said there could be. Mr. Knutson said then we may have to look at replacing 5 year old equipment if it would be split.

Supervisor Heidenreich asked about the fire alarm. Mr. Pronschinske said that is being bypassed because the current system is a proprietary system.

Supervisor Nash moved to move ahead with the whole project as outlined, second by Supervisor Heidenreich. ADOPTED.

Mr. Leu said he will write the resolution to come before this Committee on July  $2^{nd}$  and County Board on July  $11^{th}$ .

Dean Wilson thanked the Committee and the County for their support.

**BE IT FINALLY RESOLVED** that the 2013 budget be amended as follows to pay for design services:

Chair Owens thanked Ms. Gunderson for her patience and for everything she has done. He said we will all miss her.

No Smoking Signs on County Property Mr. Leu said signs have been ordered; have not heard from Parks or the fairgrounds.

<u>Communications, Announcements and Information.</u> Supervisor Heidenreich requested the UW-Rock feasibility study be added to a future agenda. Mr. Knutson said RFQs are needed first. Supervisor Heidenreich said he would like to see us move ahead with this project.

Attached are three documents for use at today's meeting.

-The first document is a memorandum from the Dean that speaks to implementation of all security system improvements, or possibly implementing only those items needed for emergency mass notification.

- -The second document is the fee proposal from Jeff Pronschinske for engineering/design services for the full project, and just the mass notification piece.
- -The third document is the page from Jeff's presentation to the Committee at the April 23<sup>rd</sup> meeting. The page shows the cost of each security system piece.

Agenda item #6 allows for discussion, and a recommendation from the Committee relative to the project's scope, and thus the cost of engineering services. If the Committee makes a recommendation at today's meeting, (or defers a decision to the next meeting) I will draft the resolution that hires Arnold & O'Sheridan for Jeff's services.

The normal meeting dates for the Committee in July would be July 2<sup>nd</sup> and July 16<sup>th</sup>. With fives Tuesday's in July, the Committee has some flexibility. As it stands now, the County Board will be meeting on July 11<sup>th</sup> and August 8<sup>th</sup>.

Unless the Committee feels differently, I do not feel it's necessary for Jeff or anyone from the Campus to be present when the Committee meets on the resolution. I would recommend that the Dean, or her designee attend the County Board meeting. Therefore the date the resolution goes to the County Board depends on the Dean's schedule.

Arnold & O'Sheridan is pleased to submit an engineering proposal for the Security Upgrade and Emergency Mass Notification System at the University of Wisconsin Rock County.

Arnold & O'Sheridan's Security Assessment dated 8/14/12 disclosed an existing security system insufficient for a campus environment, exposing the County to greater vulnerabilities associated with emergency and life safety issues. In response to this need, Arnold & O'Sheridan is pleased to provide the following engineering services as defined by Rock County General Services and the University of Rock County:

- A. Security Electronics System Upgrade
  - 1. Design upgrade and expansion of existing door control system
  - 2. Design upgrade and expansion of existing card access system
  - 3. Design upgrade and expansion of existing video surveillance system
  - 4. Design upgrade and expansion of existing duress alarm system

# Our fee for engineering the bid documents and management of the project through construction as stated above is \$ 28,000

- B. Emergency Mass Notification System Implementation
  - 1. Integrate existing voice communication system
  - 2. Design distributed antenna system
  - 3. Design emergency mass notification system

# Our fee for engineering the bid documents and management of the project through construction as stated above is \$ 41,000

The following Project related expenses will be billed as reimbursable expenses [to the extent they are reimbursable by the Owner under the Prime Agreement]:

Dear Craig, Phil, and Rob,

Thank you for supporting campus safety through the consultant's study of security systems and emergency communications at UW-Rock County. It is reassuring, especially now, to know that the County is taking active steps to help make the campus more safe and to assure the campus has the ability to respond rapidly and completely if a dangerous incident were to take place.

As you probably know, the campus already has system to "blast" emergency email and cell phone text and voice message alerts to all of the phone numbers of the Faculty, Staff, and Students who have not opted out of that system. Unfortunately, as noted in the consultant's report, there is a large gap in the audience for such alerts, namely those who are at the time of the "blast" located in our buildings, especially the lower level where there is very limited cell phone coverage. Furthermore, the campus also has an emergency notification public address system installed on the north campus (Allen Hall, Hyatt Smith Hall, and lower Andrews Hall) during the 2007-2009 construction and renovation project. Even while in an alarm state, this system can be used to address a verbal message to the campus, to every room containing an alarm strobe, which of course is very inclusive on the north campus. Unfortunately this system does not extend to the rest of the campus, and the control and annunciator panel are located in an unoccupied mechanicals room in lower Hyatt Smith some distance from administrative offices.

We appreciate the breadth of the security recommendations present in the consultant's report, and the willingness of Rock County to consider proceeding with the design of a full implementation of the security systems outlined there. At the same time, given the \$690,000 price tag of a report that is approaching one year old, and therefore could very well increase, we are wondering if it might be useful to also consider a secondary approach.


The most critical security need for the campus right now is emergency notification via a campus-wide public address system. If there were a serious threatening incident on campus such as an active shooter, we need to have some way to announce this to the campus so that Faculty, Staff, and Students across the campus can take appropriate security steps while awaiting the response of police officers. We would be most grateful if you might consider, in addition to a quote for the design of the full implementation of the security systems, requesting a quote for the design of an expansion of the existing public address system as a separate, stand alone project. Since this work would be a subset of the entire project, we believe it will likely not require substantial additional work on the part of the consultant to provide this secondary quote. And this design quote may provide Rock County and the campus with a way to move forward and resolve the most critical security need on campus – an emergency notification public address system expanded to the whole campus – at considerably less cost than the \$690,000 or more dollars required for an entire implementation. As an added benefit, it would replace the old fire and severe weather alarm system in Williams Hall, Wells Cultural Center, and first and second floors of Andrews Hall, with a contemporary alarm system that is consistent with that in the north campus.
