- 1. <u>Senior Statesmanship Program for City Government:</u> Joyce Lubben stated she followed up on Council members' request to make contact with city officials regarding a Senior Statesmanship Program that focused on city government. To date, she has not received a response.
- 2. <u>Emergency Management Planning:</u> Joyce Lubben reported she is making progress in developing an emergency management plan by becoming educated on the issue. She is attending a workshop on Long-Term Power Outage for Special Populations as well as another Emergency Planning for Special Needs Communities workshop.

She has made contact with Rodney Oksuita regarding emergency plans for nutritional needs of the elderly.

- 3. <u>Stepping On Workshop:</u> Joyce Lubben stated that a falls prevention workshop is scheduled for Thursdays, starting April 8 May 20, 2010 in Beloit. New leaders are needed for both Living Well and Stepping On.
- 4. <u>Powerful Tools Workshop:</u> A brochure on the Powerful Tools workshop was distributed. This workshop is scheduled for Wednesdays from March 10 through April 21, 2010 at the Council on Aging office.

Old Business:

1. <u>BeaconWeb Update:</u> Janet Kopp reported she has been assisting Julie Seeman in updating information for BeaconWeb. She stated it is a big job and would like to see additional committee members assist with this task. Shirley Sweet, Marti Everts, and Ellen Trewartha volunteered to assist.

New Business:

1. <u>Reauthorization of the Older Americans Act:</u> Joyce Lubben stated that the OAA reauthorization is up in 2011. The Administration on Aging is hosting listening sessions around the country to gain input on this reauthorization. There are also additional ways to provide input by going on the AoA.gov website.

- 1. <u>County Board of Supervisors:</u> Supervisor Terry Thomas stated that maintenance issues are being addressed at the Juvenile Detention Center. A resolution has been submitted to change the county coroner position to that of a medical examiner. A seminar is being held at Rotary Gardens on Best Practices in Community Policing.
- 2. <u>Bureau Briefs:</u> Joyce Lubben distributed a newsletter from the Bureau of Aging and Disability Resources that provides updates on activities and programs that are overseen by this state agency.
