CODE ALERT SYSTEM – Dave Froeber gave an update on the Wander Management system. Maintenance has installed all of the line reactors on the VFD drives. This has filtered out about 75 percent of the frequency interference that we are experiencing with the system. There were 6 VFD drives still interfering with the Wander Management system. We have ordered 6 EMI filters that target specific frequencies. They will arrive in 2 to 3 days, they will then install them and hope to have the Wander Management System up and running by the end of the month.
