Racheal would like the committee to work on the county ordinance to help with the facility's that are staffed 24 hours. Josh Smith, NHA stated that he and Sue Prostko have been discussing the issue to come up with a solution to the problem.

<u>Pathways Health</u> – Sue Prostko, NHA gave an update on what Pathways Health has been working on.
