# COUNTY BOARD STAFF COMMITTEE Minutes – March 22, 2016

<u>Call to Order</u>. Chair Podzilni called the meeting of the County Board Staff Committee to order at 4:00 P.M. in Conference Room N1 on the fifth floor of the Rock County Courthouse-East.

<u>Approval of Agenda</u>. Supervisor Arnold moved approval of the agenda as presented, second by Supervisor Mawhinney. ADOPTED.

<u>Citizen Participation, Communications and Announcements</u>. Supervisor Sweeney informed the Committee about the proposal for the Great Lakes Basin Rail Line and their plan to file a request with the Surface Transportation Board to construct and operate a rail line, which will run from Indiana through Illinois and to Milton, WI. He said there will be a public meeting on this project on Monday, April 18<sup>th</sup> at 5:30 P.M. at the Craig High School Cafeteria.

Supervisor Bussie told the Committee that at the Highway Association executive board meeting on March 1<sup>st</sup> they were informed that the governor is planning on keeping the budget flat for road repairs. She said the Janesville Gazette and Beloit Daily News both ran articles that day regarding Wisconsin roads and how so many are in need of repair.

Chair Podzilni handed out copies of the I-39/90 corridor construction schedule and asked to have copies made and handed out to the County Board on Thursday.

<u>Claim.</u> Ms. Timmerman went over the claim filed by Jenna Mangold for damage to her car caused by a county snowplow. Ms. Mangold states in her claim that she was 15 feet behind the vehicle, and State Statute requires a 20 foot distance for proper visual from the plow. She said the recommendation is to deny the claim.

Supervisor Mawhinney moved to deny the claim, second by Supervisor Arnold. DENIED.
