

COUNTY BOARD STAFF COMMITTEE Minutes – August 9, 2021

<u>Call to Order</u>. Chair Bostwick called the meeting of the County Board Staff Committee to order at 4:30 P.M. via teleconference.

<u>Approval of Agenda</u>. Supervisor Podzilni moved approval of the agenda as presented, second by Supervisor Davis. ADOPTED.

<u>Public Comment.</u> Randy Terronez introduced Judy McDonald and Irina Fursman from HueLife. Irina and Judy expressed their excitement to work with the County.

Supervisor Brien moved approval of the above resolution, second by Supervisor Sweeney. Jacki Gackstatter spoke to issues with turnover in this position due to no upward movement available. This allows for growth and advancement. There is money in the budget to cover this year. ADOPTED.

Authorizing Alternate Members to the Ad Hoc Redistricting Committee

"NOW, THEREFORE, BE IT RESOLVED by the Rock County Board of Supervisors, in session this _____ day of _____, 2021, hereby create two member-at-large alternates to Ad Hoc Redistricting Committee."

Supervisor Brien moved approval of the above resolution, second by Supervisor Beaver. ADOPTED.

<u>Reinstituting Face Covering Requirements for County Staff and Visitors to County</u> <u>Facilities</u>

"NOW, THEREFORE, BE IT RESOLVED that the Rock County Board of Supervisors, duly assembled this _____ day of ____, 2021, does hereby, effective August 16, 2021, re-institute a face covering requirement for all County staff and visitors to County facilities, consistent with the directive that was in place through May 2021.

BE IT FURTHER RESOLVED, this policy will remain in place until there have been two consecutive weeks where Rock County has been categorized as having "moderate" or "low" community transmission per CDC's data tracker, as determined by the Rock County Public Health Department, unless the Rock County Public Health Department no longer recommends that all individuals wear masks indoors or the County Board takes action either to end or extend this policy sooner"

Supervisor Podzilni moved approval of the above resolution, second by Supervisor Peer.

Josh Smith spoke to this. There has been an increase in COVID cases in Rock County. There have been discussions on whether to reinstitute this policy in County building. This was in place from June 2020 until May 2021. This resolution covers requirements and when the resolution would end. Supervisor Beaver asked for Health Department input and explanation as to why this is not coming from the Health Department. Josh clarified that the Health Department makes the decision for the whole County, not just County employees. Katrina Harwood explained that the Health Department is recommending all Rock County residents wear masks regardless of vaccination status. Supervisor Davis inquired whether any offices have closed due to COVID recently. Josh explained that no offices have closed, but some offices already have precautions in place. Supervisor Sweeney asked if the Health Department was receiving any pushback. Katrina mentioned that there has been pushback to Public Health orders, and they are trying to engage and protect residents. Supervisor Podzilni expressed his support for this resolution.

AYES – Beaver, Bostwick, Peer, Podzilni, Leavy, Davis, and Brien. NAYES – Sweeney. ABSENT – Yeomans. ADOPTED.

Review, Discussion and Possible Action.

Telework Policy Updates

Annette spoke to this. This policy was crafted in response to the Safer At Home order. This policy has been received well by employees. The presented update removes the tie to the Safer At Home order.

Supervisor Bostwick inquired whether this policy would impact facilities and space needs. Brent Sutherland responded that this would have no impact as shared workspaces allow for flexibility.

Supervisor Sweeney asked whose equipment employees are using when they are working from home. Departments worked with IT to ensure that people have equipment to work from home. As computers are up for replacement, they are being replaced with laptops. When employees are working from home, there are still ways to ensure safety. Annette explained that there also have been adjustments made to employee reviews. Supervisor Sweeney further asked if we should evaluate the need for space as we continue to allow remote work. Josh said yes, the County is taking this into account with new spaces.

Supervisor Peer emphasized the need for training on technology and communications regarding changes to security.

Supervisor Podzilni moved approval of the above resolution, second by Supervisor Davis. ADOPTED.
