Approval of Agenda. Supervisor Sweeney moved approval of the agenda as presented, second by Supervisor Bostwick. ADOPTED.

Ms. Moore, Executive Director of the YWCA, introduced Ms. Luepnitz and Ms. Dieckhoff. She explained the age of the software and equipment in use at the CARE House was purchased in 2010 and will no longer be supported. Last year approximately 200 children were interviewed by local jurisdictions and the FBI. Interviews are taped and used in court. Ms. Moore said the new equipment would give them more capabilities to ensure they would be able to capture any gestures or actions that may be of help in court. This would provide four cameras, two in each room.

Mr. Smith explained an advisory committee had been approved and appointed a number of years ago. The projects from that committee are now being implemented and feel there is need to keep the committee going to oversee these projects.

Supervisor Yeomans said he would like to see some measurement of these projects to see if it is worthwhile to fund them. Mr. Smith said the pilot will give us more information to see how well it works.

Amending Board Rules to Establish Staggered Terms of the Southern Wisconsin Regional Airport Board

hereby amend the Rock County Board Rules of Procedure as follows (<u>new language is underlined</u>; <u>deleted language is shown with a strikethrough</u>):

Amend RULE V.O. to read as follows:

- O. Airport Board
- (1) The committee shall be composed of nine members, of which three shall be County Board Supervisors. Six members shall be drawn from the community, and not elected to any county office, or employed by Rock County, and shall have a demonstrated interest or competence in the field of aviation. The terms for the six members shall commence on January 1, 2019, with one third to serve a term of 3 years, one third a term of two years, and one third a term of one year, with subsequent appointments to be a term of three years, except that any person appointed to fill a vacant position shall be appointed for the remainder of the term of the position to which appointed. The six members drawn from the community shall be limited to service of two consecutive full terms of three years, after which, members drawn from the community may serve additional terms under the preceding limitation after absence from the board for not less than one year."

Supervisor Brill moved approval of the above resolution, second by Supervisor Peer. ADOPTED.

<u>Update on Town of Beloit Incorporation</u> Mr. Smith said the next step is for the Town of Beloit to make a decision on whether or not to pursue another incorporation petition. He added, per the Beloit Daily News of January 8, 2019, a committee of Town of Beloit staff members will help the Town Board make this decision. The Town of Beloit needs to get back to the Incorporation Review Board by March 15, 2019 if they want to resubmit.
