Review, Discussion and Possible Action on Administrative Policy No. 5.45 - Uniform / Equipment Allowance. Ms. Mikula explained that the cleaning allowance for the RECAP Supervisor, Correctional Supervisor, Financial Office Manager, Administrative Secretary, and Secretary I/II had not been updated in the policy. Supervisor Brill moved approval of the changes to Policy No. 5.45, second by Supervisor Mawhinney. The Committee discussed the need of a uniform cleaning allowance if uniforms are not worn; the amounts of various uniform expenses; and the inconsistencies within or between departments. Supervisor Mawhinney moved to postpone action indefinitely for further investigation, second by
