<u>Call to Order</u>. Chair Podzilni called the meeting of the County Board Staff Committee to order at 4:00 P.M. in Conference Room N-1 on the fifth floor of the Rock County Courthouse-East.

<u>Approval of Agenda</u>. Supervisor Arnold moved approval of the agenda as presented, second by Supervisor Peer. ADOPTED.

Revised County Municipal Agreement between Rock County and the City of Janesville for Construction of a Commercial Access onto County Highway G (Beloit Avenue)

"NOW, THEREFORE, BE IT RESOLVED, that the County Board of Rock County assembled this _____ day of ______, 2015 approves the entering of said County-Municipal Agreement for a Commercial Access Design, Right-of-Way acquisition and Construction, with the City of Janesville paying 100% of the additional design, real estate and construction costs; and,

BE IT FURTHER RESOLVED, that the County Board of Rock County authorizes the County Board Chair to execute the County-Municipal Agreement with the City of Janesville."

Supervisor Bussie moved approval of the above resolution, second by Supervisor Peer. ADOPTED.

Reallocating the Position of Surveyor and Reorganizing the Surveyor's Department

"NOW, THEREFORE, BE IT RESOLVED, that the Rock County Board of Supervisors assembled this _____ day of ______, 2015 does hereby reallocate the position of Surveyor from Pay Range 23 to Pay Range 21 effective October 1, 2015 and approves the reorganization of the Surveyor's Office to be organizationally placed under supervision of the Planning and Development Department."

Supervisor Sweeney moved approval of the above resolution, second by Supervisor Arnold.

Mr. Smith said after doing research to look for ways to more efficiently run departments, and with the County Surveyor resigning, we felt this would be a good time to combine the Surveyor and the Planning and Development Departments. This change makes sense and will offer more customer service coverage.

Supervisor Sweeney said the Planning and Development Committee oversees both departments now and they are in support of these changes.

ADOPTED.

Approval of Social Media Policy.

Supervisor Sweeney moved to approve the Social Media Policy as handed out to the committee (attached), second by Supervisor Bussie.

Mr. Osborne explained the only change made to the previous version, from the last meeting, is on page 3, to add "Please note that the views expressed on the social media website does not reflect the views of Rock County or the County Board of Supervisors."

Supervisors Kraft and Arnold requested the policy be reviewed a year from now to see how it is working and if there are any problems. Mr. Osborne agreed and said it will probably be a continuous as needed basis.
