

# COUNTY BOARD STAFF COMMITTEE Minutes – August 9, 2016

<u>Call to Order</u>. Chair Podzilni called the meeting of the County Board Staff Committee to order at 4:00 P.M. in Conference Room N1 on the fifth floor of the Rock County Courthouse-East.

<u>Discussion and Possible Action on Use of Rock County Logo by United Way.</u> Mr. Osborne gave a brief background on the Voluntary Action Center's vote to dissolve in January 2016 and the United Way Get Connected Volunteer System program. He said this request for use of the County Seal would be limited to just this program.

The Committee discussed the pros and cons on use of the County Seal outside of the County's use.

Moved by Supervisor Sweeney to postpone until the next meeting to get more information, second by Supervisor Arnold. POSTPONED to the next meeting.

<u>Claim.</u> Mr. Kuglitsch went over the \$9,762.76 claim filed by Danyel Gritzner for damage to his vehicle while traveling on Highway 14 during the seal coating project being done for the Wisconsin Department of Transportation. Signage was placed 10 days prior to the work being done.

Supervisor Sweeney moved to deny the claim, second by Supervisor Mawhinney. DENIED.
