## Amending and Approving the 2015 Unilateral Pay Grid Appendix A-1 Sheriff's Command Staff and Creating a New Appendix A-2 Correctional Supervisor

<u>Discussion and Possible Action on Cell Tower at the W. Court Street Tower.</u>
Mr. Terronez went over the offer from AT&T and said the lease expires in 2018.

The Committee discussed the offer, and various counter-offers.

Supervisor Arnold moved to hold off on any decisions until we are closer to the date, second by Supervisor Sweeney. ADOPTED.
