# Transferring Central Duplicating and Mail Functions and Staff from the Facilities Management Department to the Finance Department and Amending the 2016 Budget

"NOW, THEREFORE, BE IT RESOLVED, that the Rock County Board of Supervisors duly assembled this \_\_\_\_\_\_ day of \_\_\_\_\_\_\_, 2016 does hereby approve the transfer of the central duplicating and mail operation functions from the Facilities Management Department to the Finance Department effective June 6, 2016.

**BE IT FURTHER RESOLVED,** that 1.0 FTE Administrative Assistant and 0.4 FTE Printing Services Coordinator be transferred from the Facilities Management Department to the Finance Department.

**BE IT FINALLY RESOLVED**, that the Facilities Management Department and Finance Department 2016 Budgets be amended as follows:

Supervisor Mawhinney moved approval of the above resolution, second by Supervisor Kraft. Supervisor Bussie requested a report back from each department in a few months to see how this change is working. ADOPTED.

## <u>Authorizing Accounting Office Position Changes for the Department of Public Works</u>

"NOW, THEREFORE, BE IT RESOLVED, that the Rock County Board of Supervisors duly assembled this \_\_\_\_\_\_ day of \_\_\_\_\_\_, 2016 does hereby authorize creation of a Cost Allocation Specialist and deletion of the current Account Clerk II position at DPW; and,

**BE IT FURTHER RESOLVED,** that the Department may hire sufficient temporary staff to accomplish the work of the accounting office until such time as the processes and duties are being reconfigured and a new employee is hired."

Supervisor Arnold moved approval of the above resolution, second by Supervisor Bussie.

Supervisor Mawhinney asked what the timeline is for the new time keeping software. Mr. Coopman said 90 days. Supervisor Mawhinney moved to postpone the resolution for 90 days with provision to allow additional temporary help for data entry. FAILED due to lack of second.

Supervisor Kraft stated that this is a complex resolution. Waiting 90 days won't make it any simpler. Mr. Smith said that essentially this is a two part resolution. One being the creation of the Cost Allocation Specialist with deletion of the Account Clerk II position. Second being hiring temporary staff to accomplish the work of the accounting office. Mr. Smith reminded the committee that a resolution is not required to assign temporary help. Supervisor Bussie stated that we have to trust Mr. Coopman and Mr. Smith with the job at hand. Supervisor Mawhinney would like an update at the end of June. As this is only a few weeks away, Mr. Coopman suggested an update by the end of July and if done sooner he will have this placed on the agenda. ADOPTED.

<u>Discussion of Buck Property.</u> There has been no recent discussion on how we would like to proceed with the property. Mr. Coopman would like the committee to consider dispositioning the Buck property as a County park. At the last PWC Park's meeting, they discussed resurrecting the boat launch. There is no other public access on that side of the dam. Supervisor Sweeney has no objections to exploring the options. Mr. Coopman said that some funding may be available through the waterways commission. Mr. Coopman will have a rough draft drawn up including costs and return to this

committee in four weeks. Supervisor Kraft would still like to see the property sold to a home builder. It was suggested that the property be listed with two real estate agents simultaneously. Names of real estate agents should be submitted to Mr. Terronez before our next meeting.

<u>Adjournment</u>. Supervisor Arnold moved adjournment at 5:27 P.M., second by Supervisor Peer. ADOPTED.
