# Opposition to Senate Bill 326/Assembly Bill 429 Affecting Child Welfare Practice

**BE IT FURTHER RESOLVED** that the County Clerk be directed to send a copy of this resolution to Rock County's legislative delegation, the authors of the bill, and the Wisconsin Counties Association."

Supervisor Thomas moved approval of the above resolution, second by Supervisor Brill.

Mr. Smith said this resolution originated in the Human Services Department because they have concerns with some of the proposed legislation such as: all reports of child abuse and neglect will require referrals to law enforcement within 12 hours after the report is received; this would include all reports whether they have been screened out or

not; and the Wisconsin Counties Association is against this as it is written, they feel more work needs to be done on this bill before it becomes law.

Supervisor Thomas said Rock County does a very good job on these cases and this bill would increase the workloads and create overtime. He said the counties over 500,000 are the ones who seem to need this the most.

#### ADOPTED.

<u>Inclement Weather Policy Update.</u> Mr. Smith said on the policy update, done a few months ago, the essential positions were not included in the update. He asked the Committee for approval to update the list to show the additions, deletions and title changes.

Supervisor Arnold moved approval of the changes to the essential employee list, second by Supervisor Bussie. ADOPTED.

# <u>Discussion on Establishing the Salary for Rock County Clerk, Register of Deeds, and Treasurer for the 2017-2020 Term.</u>

Ms. Mikula and Mr. Smith handed out and went over the previous salary and if they would follow the Clerk of Courts salary they would be: 1/1/2017 \$74,980, which is a 2% increase; and 1/1/2018 \$76,480, which is a 2% increase. Ms. Mikula asked what the Committee would want for 2019 and 2020 salaries.

Discussion on what comparable counties are paying, and that the salaries should be in line with what the other employees are getting.

Chari Podzilni asked to have this put back on one of the January meetings.

<u>Claims.</u> Mr. Kuglitsch went over the claims and explained they are all related to the same accident which occurred on August 1, 2015 at the intersection of N. Pleasant and County Road C. He said WMMIC has reviewed the claims and recommend denial as the Town of Union is responsible for the roads.

Supervisor Sweeney moved to deny the claims, second by Supervisor Bussie. ADOPTED.

<u>Adjournment</u>. Supervisor Arnold moved adjournment at 4:40 P.M., second by Supervisor Brill. ADOPTED.
