## CRIMINAL JUSTICE COORDINATING COUNCIL Minutes – May 20, 2021

- <u>Call to Order</u>. Chair Mattingly called the meeting of the Criminal Justice Coordinating Council to order at 3:03 P.M. via teleconference.

- <u>Approval of Agenda</u>. Mr. Howland moved approval of the agenda, second by Supervisor Williams. ADOPTED.
- <u>Approval of Minutes of April 15, 2021</u>. Ms. Luster moved approval of the minutes of April 15, 2021 as presented, second by Supervisor Williams. ADOPTED.
- <u>Fight Crime: Invest in Kids Presentation.</u> Chair Mattingly introduced Eoin Dillon. Mr. Dillon provided a PowerPoint presentation for the committee on steering kids towards productive lives and away from crime.
- <u>Pretrial Presentation JusticePoint.</u> Mr. Gutjahr shared a PowerPoint presentation with the committee on pretrial services and the public safety assessment and how these items are working in Rock County.
- Approval of Resolution Proclaiming May 2021 Treatment Court Month. Mr. Brigham moved to support the resolution Proclaiming May 2021 Treatment Court Month, second by Ms. Luster. ADOPTED.

# <u>Discussion Regarding Criminal Justice System Racial and Ethnic Disparities</u> <u>Improvement Goals.</u>

- <u>Updates from CJCC Agencies.</u> Ms. Luster said Alia Innovations has received funds to work with Rock County Human Services to reduce family separation and eliminate racial disparities in foster care in Rock County.
- <u>Update on Racial Disparities in the Juvenile Justice System.</u> Mr. Brown said a survey went out to all partners. They will formulate their next steps based off the data that is gathered.

<u>Discussion regarding Criminal Justice System Responses to Domestic Violence.</u> Dr. Schiffman said they are currently reviewing the data on the Mondy case and Domestic Violence in general.

<u>Jail Renovation Update.</u> Sheriff Knudson said he is pleased with the design thus far. There is a resolution going before the County Board next week to combine Phase I and Phase II for a more efficient building design. Sheriff Knudson said they met with some focus groups to gather ideas. He explained some of the design plans.

<u>Discussion Regarding Law Enforcement Concerns</u>. Sheriff Knudson shared contact information of an individual that could do a presentation on Marsy's Law.

Sheriff Knudson said he asked inmates to participate in a voluntary creative writing project. He said eighteen inmates participated. He was impressed with some of the submissions. They have a new phone contract for inmates that is going well. A one-on-one tablet initiative is starting next week. Body cameras are being ordered for the corrections side; already installed with law enforcement side. They will have several events coming up during the summer. Information will be on their social media platform.
