<u>May 27, 2020</u>

<u>CALL TO ORDER</u> – Chair Brien called the teleconference meeting of the Health Services Committee to order at 9:27 a.m.

<u>COMMITTEE MEMBERS PRESENT</u>: Chair Brien, Beaver, Schulz, Leavy, and Bomkamp

<u>STAFF MEMBERS PRESENT</u>: Taya Walk, NHA; Sara Beran, Director of Nursing; David Froeber, Facilities Superintendent; Joanne Foss, Controller

<u>OTHERS PRESENT</u> – Josh Smith, County Administrator; Marilyn Bondehagen, Administrator Office Coordinator; Richard Bostwick, County Board Vice Chair

<u>APPROVAL OF AGENDA</u> – Supervisor Bomkamp moved approval of agenda, second by Supervisor Beaver. ADOPTED

<u>APPROVAL OF MINUTES – March 11, 2020</u> – Supervisor Bomkamp moved approval of the March 11, 2020 minutes, second by Supervisor Beaver. APPROVED

<u>ELECTION OF VICE CHAIR</u> - Supervisor Bomkamp nominated Supervisor Beaver for Vice Chair, second by Supervisor Leavy. Vote of 5/0 in favor. Supervisor Beaver accepted the Vice Chair.

<u>SET MEETING DATE AND TIME</u> – Discussion on if when meeting start back in person and a Supervisor can't make the meeting, can zoom be used to call in. Josh Smith stated that as of now, only in emergency's can meetings be held electronically. County Board policy prevents electronic meetings.

Supervisor Beaver made a motion to have the Health Service Committee meet the second Wednesday at 9:00am. Second by Supervisor Bomkamp. APPROVED

<u>REVIEW OF PAYMENTS</u> – Committee reviewed payments.

<u>FINANCE</u> – Joanne Foss gave a copy of the Rock Haven fourth quarter 2019 financial results report. Rock Haven received 3 stimulus checks totaled \$571,497.00 and might get another one. A separate account was created for COVID expense, to be able to track what has been spent.

<u>NURSING HOME ADMINISTRATOR REPORTS</u> - Taya Walk, NHA went over her 90 day plan. COVID 19 has taken over most of her time, but stated that she is working on the communication. The departments meet every morning and every afternoon to communicate the things that are being done in the building.

Taya is also creating templates to give information to the HSC. She will create a couple for the committee to decide on what information and what template they would prefer at the next meeting.

A family newsletter went to all residents and families in May and will continue to monthly. Notifications have been going out to families to notify of positive COVID tests. This is being done by phone and memos. Texting the staff when needed to notify of changes.

Michelle Kelm has completed the quarterly PBJ and should help the staff star rating.

Taya Walk is the grievance officer and working on closing any grievance as soon as possible, within 3-5 days. Supervisor Shulz asked when she would bring any concerns of a grievance to the committee. Taya stated she could add grievances to the template that will be used as communication.

In the billing area, a triple check is being done. To make sure that everything that is being billed is accurate and not billing for any services that were not completed. Making sure that the date of service and diagnosis is accurate.

OLD BUSINESS - None

NEW BUSINESS -

<u>COVID-19</u> – Taya Walk, NHA gave an update on the positive COVID cases. Eight resident have tested positive, with one passing in the hospital. All the resident are housed on the same unit and the unit is shut down at this time, which means that the staff working there can't be moved to any other unit and must enter and exit from the unit doors. All staff on that unit are wearing N95 mask and face shields with the other PPE. All residents are encouraged to stay in their rooms and kitchen is using all disposable utensils for meals to eat in their rooms. Health Services Committee May 27, 2020 Page 3

Supervisor Bomkamp asked if Rock Haven has enough PPE. Sara Beran, Director of Nursing said that being creative with gowns and it is a daily struggle to collect what they can to provide staff with the equipment. Face shields and N95 masks have been assigned to staff. PPE shipment from the state and donation from the fire department is helping.

Josh Smith stated that an EOC shipment arrived yesterday and should be receiving soon. Public works has hand sanitizer if needed.

Supervisor Bomkamp wanted to know if the closest door was correct for the fire department. Yes, the closest door to the resident is where the fire department should pull up to. Supervisor Bomkamp wanted to thank all the Rock Haven staff for coming in everyday under current conditions and wearing all the PPE.

Taya Walk informed the committee that there is a unit on LE that is designated for COVID patients and that 5 rooms are ready to go. Maintenance needed to get the negative air pressure for the unit and working on the other rooms.

Rock Haven is working on a contract with Pathway Health to help with infection control and survey readiness. Also a contract with a staffing agency to help with staffing the COVID.

Taya stated that Rock Haven is preparing for survey and documenting all the cleaning to prevent spread of infections. Hand washing audits are being conducted for all staff. Education is continually going to staff with updated policy and procedures.

Rock Haven applied for a state grant and received \$3,000 to purchase electronic equipment for the residents to use to contact family and friends.

Josh Smith said and anonymous email was sent to the Janesville Gazette about the COVID in Rock Haven.

Tom Brien complimented Taya Walk for notifying the board and communicating the changes that are happening in the building.
