<u>Approval of Minutes of September 9 and September 29, 2010.</u> Supervisors Fox and Arnold moved the minutes of September 9 and September 29. MOTION CARRIED.

<u>Citizen Participation, Communications, and Announcements.</u> Supervisor Bussie discussed recent goings-on of the Wisconsin County Highway Association.

HIGHWAY BUSINESS

Approve Resolution: Authorizing Purchase of Automated Vehicle Locating System and Amending the DPW Budget. Supervisors Arnold and Fox moved the resolution. Mr. Coopman explained WisDOT requested that we put Automated Vehicle Locating Systems on the 20 vehicles operated on state highways. They will reimburse us 100% of the purchase and installation and first year's operating costs. An additional 60 units are being requested in this resolution to be installed on county vehicles. Discussion. MOTION CARRIED.

Minutes of the Rock County Public Works Committee October 14, 2010

Approve Resolution: Support of Widening and Improving Interstate Highway 39/90 in Rock and Dane Counties. Supervisors Arnold and Fox moved the resolution. MOTION CARRIED.

<u>Approve Budget Transfer for DPW Building Lighting Design Consultant.</u> Supervisors Fox and Bussie moved the transfer. Discussion. MOTION CARRIED.

<u>Amend Bridge Aid Petition – Creek Road – Town of Bradford.</u> Supervisors Bussie and Fox moved the request. Mr. Coopman explained the cost of this culvert went up from \$1,675 to \$3,350 and the Town wants to apply for more aid. MOTION CARRIED.

<u>Approve Bridge Aid Petitions – Kettle Road and Orfordville-Hanover Road – Town of Plymouth.</u> Supervisors Bussie and Arnold moved the bridge aid petitions for culvert replacements on Kettle Road for \$27,156 and Orfordville-Hanover Road for \$37,523. MOTION CARRIED.

Approve Purchase of Suspended Lube Rack. Supervisors Fox and Arnold moved the purchase of the suspended lube rack from Oil Equipment Company for \$9,557. Mr. Turk explained this equipment holds hose reels for oil and air to service vehicles in the shop. MOTION CARRIED.

Approve Request from Town of Porter to be Released from 2010 & 2011 Town Road Maintenance Agreements. Supervisors Arnold and Bussie moved the request. A written formal request from the Town had not been received. A lengthy discussion ensued. Supervisors Fox and Bussie moved to table this request until the Airport meeting on October 26. MOTION CARRIED.

COMMISSIONER'S REPORT

<u>Attendance at WisDOT Southwest Region Annual Fall Meeting.</u> This will be held in Spring Green on November 5. Supervisors Arnold and Bussie plan to attend along with Public Works Director Coopman.

Mr. Coopman discussed a drainage problem on CTH S near Sweet-Allyn County Park, involving property owned by Floyd Johnson. He will send Mr. Johnson a letter explaining the County's position on the matter.

Discussion on Town of Union's Leedle Mill Road bridge took place. Design on the project is nearly complete and it will be bid out by the State for construction in 2011.

Mr. Coopman discussed work being done on a bridge on Interstate Highway 39/90 over Newville Road. Newville Road will be blocked off for about six weeks. A detour has been posted.
